- 2 relating to efforts to encourage full participation in the 2020
- federal decennial census by the residents of this state, including 3
- the establishment of the Complete Count Commission. 4
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. SHORT TITLE. This Act may be cited as the Every
- 7 Texan Counts Act.
- SECTION 2. DEFINITIONS. In this Act: 8
- (1) "Commission" means the Complete Count Commission 9
- created by this Act. 10
- "Local government" means a municipality or county. 11 (2)
- 12 (3) "Member" means a member of the commission.
- 13 (4)"State agency" means a board, commission,
- 14 department, office, or other agency that is in the executive branch
- of state government and was created by the constitution or a statute 15
- 16 of this state.
- SECTION 3. COMMISSION. (a) The commission is composed of 17
- the following members: 18
- seven persons appointed by the governor; 19
- 20 one person appointed by the governor from a list
- 21 submitted by the speaker of the house of representatives;
- 22 one person appointed by the lieutenant governor;
- 23 (4) one person from each of the 10 most populous
- 24 counties in this state, nominated by the county's respective county

- 1 judge;
- 2 (5) seven members from business, faith, and nonprofit
- 3 community-based organizations, appointed by the governor, to
- 4 represent the demographic, economic, and linguistic diversity of
- 5 this state;
- 6 (6) five members appointed by the secretary of state
- 7 to represent traditionally hard-to-count populations, three of
- 8 whom must be from counties located on the Texas-Mexico border;
- 9 (7) if a local government has created a local complete
- 10 count commission, members designated by the local commission; and
- 11 (8) the secretary of state, who serves as the chair of
- 12 the commission.
- 13 (b) A member serves at the pleasure of the member's
- 14 appointing official and vacancies shall be filled in the same
- 15 manner as the initial appointment. The commission shall meet not
- 16 later than the 30th day after the date initial appointments are made
- 17 under Subsections (a) (1)-(6) of this section. The commission shall
- 18 meet regularly as necessary at the call of the chair.
- 19 (c) A member may not receive compensation for service on the
- 20 commission, but is entitled to reimbursement for actual and
- 21 necessary expenses incurred in performing commission duties. The
- 22 commission may accept gifts, grants, and donations to pay for those
- 23 expenses.
- 24 (d) The commission may employ a director and assistant
- 25 director on a two-thirds vote of the full membership of the
- 26 commission. The director and assistant director may be compensated
- 27 from money appropriated or available for that purpose.

- 1 SECTION 4. CENSUS OUTREACH STRATEGY. (a) The commission
- 2 shall develop, recommend, and assist in the administration of a
- 3 census outreach strategy to encourage full participation in the
- 4 2020 federal decennial census of population required by 13 U.S.C.
- 5 Section 141.
- 6 (b) The census outreach strategy must include:
- 7 (1) state agency initiatives to encourage
- 8 participation in the 2020 federal decennial census;
- 9 (2) the establishment and support of school-based
- 10 outreach programs;
- 11 (3) partnerships with nonprofit community-based
- 12 organizations; and
- 13 (4) a multilingual, multimedia campaign designed to
- 14 ensure an accurate and complete count of this state's population.
- 15 (c) To assist in carrying out its duties, the commission may
- 16 create and appoint subcommittees as appropriate and shall solicit
- 17 participation from relevant experts and practitioners involved in
- 18 census issues.
- 19 (d) The secretary of state shall:
- 20 (1) coordinate the census outreach strategy;
- 21 (2) provide administrative support to the commission;
- 22 and
- 23 (3) coordinate with all state agencies and
- 24 constitutional officers, as well as local governments, to identify
- 25 effective methods of outreach to residents of this state and to
- 26 provide resources to ensure the outreach program is successful and
- 27 that all residents of this state are counted.

- 1 (e) A state agency shall inform the secretary of state of
- 2 the agency's designated census coordinator and cooperate with and
- 3 provide support to the commission. Other state governmental
- 4 entities and local governments shall cooperate and provide all
- 5 reasonable assistance to the commission.
- 6 (f) Not later than December 31, 2019, the commission shall
- 7 submit a written report to the governor, lieutenant governor,
- 8 speaker of the house of representatives, and members of the
- 9 legislature with its recommendations and findings, including a
- 10 recommended outreach strategy for implementation for the 2020
- 11 federal decennial census.
- 12 SECTION 5. GRANT PROGRAM. (a) Using available funds or
- 13 private donations, the governor shall establish and administer a
- 14 grant program to award grants to local governments for their
- 15 outreach efforts to encourage full participation in the 2020
- 16 federal decennial census of population required by 13 U.S.C.
- 17 Section 141.
- 18 (b) The governor shall adopt rules to implement and
- 19 administer the grant program created under this section, including
- 20 rules regarding applications by and eligibility of local
- 21 governments for grants under the program. Eligibility rules must
- 22 prioritize a local government that has:
- 23 (1) established census outreach efforts; and
- 24 (2) census tracts with traditionally hard-to-count
- 25 populations within its boundaries.
- 26 (c) The governor may accept gifts, grants, and donations for
- 27 the grant program created under this section.

- 1 SECTION 6. INITIAL APPOINTMENTS. As soon as practicable
- 2 after the effective date of this Act, the appointing officials
- 3 shall appoint members to the commission as provided by Section 3(a)
- 4 of this Act.
- 5 SECTION 7. ABOLISHMENT AND EXPIRATION. The commission and
- 6 the grant program created under this Act are abolished and this Act
- 7 expires on September 1, 2021.
- 8 SECTION 8. EFFECTIVE DATE. This Act takes effect
- 9 immediately if it receives a vote of two-thirds of all the members
- 10 elected to each house, as provided by Section 39, Article III, Texas
- 11 Constitution. If this Act does not receive the vote necessary for
- 12 immediate effect, this Act takes effect September 1, 2019.
