3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Section 1.04 , Tax Code, is amended by adding
5	Subdivisions (20) and (21) to read as follows:
6	(20) "Heir property" means real property:
7	(A) owned by one or more individuals, at least
8	one of whom claims the property as the individual's residence
9	homestead; and
10	(B) acquired by the owner or owners by will,
11	transfer on death deed, or intestacy, regardless of whether the
12	interests of the owners are recorded in the real property records of
13	the county in which the property is located.
14	(21) "Heir property owner" means an owner of heir
15	property who claims the property as the individual's residence
16	homestead.
17	SECTION 2. Chapter 5, Tax Code, is amended by adding Section
18	5.061 to read as follows:
19	Sec. 5.061. EXPLANATION OF INFORMATION RELATED TO HEIR
20	PROPERTY. (a) The comptroller shall prepare and electronically
21	publish a pamphlet that provides information to assist heir

- 25 the sole owner of the property for the purposes of this section.
- SECTION 5. Section 11.41, Tax Code, is amended by adding

- 3 the sole owner of the property for the purposes of this section.
- 4 SECTION 6. Section 11.43, Tax Code, is amended by amending
- 5 Subsection (o) and adding Subsection (o-1) to read as follows:
- 6 (o) The application form for <u>a residence homestead</u> [an]
- 7 exemption [authorized by Section 11.13] must require an applicant
- 8 [for an exemption under Subsection (c) or (d) of that section] who
- 9 is not specifically identified on a deed or other appropriate
- 10 instrument recorded in the [applicable] real property records of
- 11 the county in which the property is located as an owner of the
- 12 residence homestead, including an heir property owner, to provide:

- 18 (3) a copy of the most recent utility bill for the

- 20 (4) a citation of any court record relating to the
- 21 applicant's ownership of the property if available [homestead].
- 22 (o-1) The application form for a residence homestead
- 23 exemption may not require an heir property owner to provide a copy
- 24 of an instrument recorded in the real property records of the county
- 25 in which the property is located.
- SECTION 7. Subchapter C, Chapter 11, Tax Code, is amended by
- 27 adding Section 11.49 to read as follows:

- 1 Sec. 11.49. LEGAL TITLE NOT AFFECTED. (a) The grant or
- 2 denial of an application by an heir property owner for a residence
- 3 homestead exemption under this chapter does not affect the legal
- 4 title of the property subject to the application and does not
- 5 operate to transfer title to that property.
- 6 (b) An appraisal district, chief appraiser, or appraisal
- 7 review board may not be made a party to a proceeding to adjudicate
- 8 ownership of property described by Subsection (a) except as
- 9 prescribed by this title.
- SECTION 8. Section 33.06, Tax Code, is amended by adding
- 11 Subsection (h) to read as follows:
- 12 (h) An heir property owner who qualifies heir property as
- 13 the owner's residence homestead under Chapter 11 is considered the
- 14 sole owner of the property for the purposes of this section.
- SECTION 9. Section 33.065, Tax Code, is amended by adding
- 16 Subsection (j) to read as follows:
- 17 (j) An heir property owner who qualifies heir property as
- 18 the owner's residence homestead under Chapter 11 is considered the
- 19 sole owner of the property for the purposes of this section.
- SECTION 10. Not later than January 1, 2020, the comptroller
- 21 of public accounts shall make available the pamphlet required by
- 22 Section 5.061, Tax Code, as added by this Act.
- 23 SECTION 11. The changes in law made by this Act apply only
- 24 to an ad valorem tax year that begins on or after the effective date
- 25 of this Act.
- 26 SECTION 12. This Act takes effect September 1, 2019.
