4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 342.005, Finance Code, is amended to
6	read as follows:
7	Sec. 342.005. APPLICABILITY OF CHAPTER. Except as provided
8	by Sections $302.001(d)$ and $342.004(c)$, a loan is subject to this
9	chapter if the loan:
10	(1) provides for interest in excess of 10 percent a
11	year;
12	(2) is extended primarily for personal, family, or
13	household use to a person who is located in this state at the time
14	<pre>the loan is made;</pre>
15	(3) is made by a person engaged in the business of
16	making, arranging, or negotiating those types of loans; and
17	(4) either:
18	(A) is not secured by a lien on real property; or
19	(B) is described by Section 342.001(4), 342.301,
20	or 342.456 and is predominantly payable in monthly installments.
21	SECTION 2. The heading to Section 342.053, Finance Code, is

- Sec. 352.009. APPLICABILITY OF CHAPTER. This chapter
- 26 applies to a refund anticipation loan that is extended to a person
- 27 who is located in this state at the time the loan is made.

- 1 SECTION 13. Section 371.003(8), Finance Code, is amended to
- 2 read as follows:
- 3 (8) "Pawn transaction" means the pledging, by a person
- 4 present in this state at the time of the transaction, with a
- 5 pawnbroker of a single item of goods as security for a loan of
- 6 money.
- 7 SECTION 14. Section 393.602(a), Finance Code, is amended to
- 8 read as follows:
- 9 (a) This subchapter applies only to a credit services
- 10 organization that, with respect to a consumer who is located in this
- 11 state at the time of the transaction, obtains for a consumer or
- 12 assists a consumer in obtaining an extension of consumer credit in
- 13 the form of:
- 14 (1) a deferred presentment transaction; or
- 15 (2) a motor vehicle title loan.
- 16 SECTION 15. This Act takes effect September 1, 2019.
