A BILL TO BE ENTITLED

1	AN ACT
2	relating to a study by the Texas Education Agency of career and
3	technology education programs.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter F, Chapter 29, Education Code, is
6	amended by adding Section 29.193 to read as follows:
7	Sec. 29.193. STUDY AND REPORT ON CREDENTIALS AND
8	CERTIFICATES. (a) The agency shall conduct a study to:
9	(1) evaluate the industry-recognized credentials and
10	certificates that are currently being offered to public high school
11	students through career and technology education programs in each
12	region of the state; and
13	(2) identify any unmet needs in career and technology
14	education programs currently being offered to public high school
15	students in each region of the state.
16	(b) The study must:
17	(1) for each region of the state:
18	(A) evaluate:
19	(i) the industry-recognized credentials or
20	certificates currently being offered to public high school students
21	through career and technology education programs in the region; and
22	(ii) the knowledge and skills necessary to
23	meet workforce needs in the region; and
24	(B) identify:

1	(i) any gaps between the
2	industry-recognized credentials or certificates identified under
3	Paragraph (A)(i) and the knowledge and skills identified under
4	Paragraph (A)(ii); and
5	(ii) any knowledge or skills that could be
6	incorporated into career and technology education programs in the
7	region to increase students' marketability in that region after
8	graduation from high school; and
9	(2) for each currently offered industry-recognized
10	credential or certificate, assess the economic impact of earning
11	the credential or certificate in each region of the state,
12	including:
13	(A) the average industry wage for a student who
14	has earned the credential or certificate in each region; and
15	(B) the demand to employ a student in each region
16	for the credential or certificate.
17	(c) Not later than September 1, 2021, the agency shall
18	submit to the commissioner a report that:
19	(1) identifies any currently offered
20	industry-recognized credential or certificate that does not
21	provide a sufficient positive economic impact in any region of the
22	state based on the assessment conducted under Subsection (b)(2);
23	(2) recommends the creation of industry-recognized
24	credentials or certificates for each region of the state to be
25	offered in a career and technology education program in that region
26	that will address unmet workforce needs and enhance student
27	competitiveness in the labor market; and

- 1 (3) provides recommendations for issuing guidance to
- 2 public schools on how to use labor market information generated by
- 3 state agencies in designing career and technology education
- 4 programs and courses.
- 5 (d) This section expires September 1, 2022.
- 6 SECTION 2. The Texas Education Agency is required to
- 7 implement a provision of this Act only if the legislature
- 8 appropriates money specifically for that purpose. If the
- 9 legislature does not appropriate money specifically for that
- 10 purpose, the Texas Education Agency may, but is not required to,
- 11 implement a provision of this Act using other appropriations
- 12 available for that purpose.
- 13 SECTION 3. This Act takes effect immediately if it receives
- 14 a vote of two-thirds of all the members elected to each house, as
- 15 provided by Section 39, Article III, Texas Constitution. If this
- 16 Act does not receive the vote necessary for immediate effect, this
- 17 Act takes effect September 1, 2019.
