- 2 relating to the Texas Diabetes Council and the state plan for
- 3 diabetes and obesity treatment and education.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 103.001(2), Health and Safety Code, is
- 6 amended to read as follows:
- 7 (2) "Person with diabetes" means a person diagnosed by
- 8 a physician in accordance with nationally recognized standards as
- 9 having diabetes.
- SECTION 2. Sections 103.002(a), (b), and (c), Health and
- 11 Safety Code, are amended to read as follows:
- 12 (a) The Texas Diabetes Council is composed of 11 citizen
- 13 members appointed from the public and one representative each from
- 14 the department, the commission, the Employees Retirement System of
- 15 Texas, the Teacher Retirement System of Texas, and the Texas
- 16 Workforce Commission vocational rehabilitation services division
- 17 [Department of Assistive and Rehabilitative Services].
- 18 (b) The governor, with the advice and consent of the senate,
- 19 shall appoint the following citizen members:
- 20 (1) a licensed physician with a specialization in
- 21 treating diabetes;
- 22 (2) a registered nurse with a specialization in
- 23 diabetes education and training;
- 24 (3) a registered and licensed dietitian with a

- 1 specialization in the diabetes education field;
- 2 (4) a person with experience and training in public
- 3 health policy;
- 4 (5) three consumer members, with special
- 5 consideration given to persons active in the Texas affiliates of
- 6 the Juvenile Diabetes Research Foundation (JDRF), the American
- 7 Association of Diabetes Educators, or the American Diabetes
- 8 Association; and
- 9 (6) four members from the general public with
- 10 expertise or demonstrated commitment to diabetes issues.
- 11 (c) The commissioner, executive commissioner, executive
- 12 director of the Employees Retirement System of Texas, executive
- 13 <u>director of the Teacher Retirement System of Texas</u>, and <u>the</u>
- 14 <u>director</u> of the Texas Workforce Commission vocational
- 15 rehabilitation services division [commissioner of assistive and
- 16 rehabilitative services] shall appoint that agency's
- 17 representative to the council. Agency representatives shall be
- 18 nonvoting members of the council.
- 19 SECTION 3. Section 103.010, Health and Safety Code, is
- 20 amended to read as follows:
- Sec. 103.010. STAFF AND ADMINISTRATIVE SUPPORT. (a) Each
- 22 agency represented on the council shall provide the council with
- 23 periodic staff support of specialists as needed and may provide
- 24 staff support to an advisory committee.
- 25 (b) The department shall provide administrative support to
- 26 the council by providing research services and preparing any
- 27 reports required under this chapter.

- 1 SECTION 4. Section 103.011, Health and Safety Code, is
- 2 amended to read as follows:
- 3 Sec. 103.011. ADVISORY COMMITTEES; WORK GROUPS. (a) The
- 4 council may establish advisory committees or work groups that the
- 5 council considers necessary and may determine the appropriate
- 6 membership for each committee or group.
- 7 (b) The council shall specify the purpose and duties of each
- 8 advisory committee or work group and shall specify any product the
- 9 committee is required to develop.
- 10 (c) Members of an advisory committee or work group serve at
- 11 the will of the council. The council may dissolve an advisory
- 12 committee or work group when necessary.
- SECTION 5. Section 103.013, Health and Safety Code, is
- 14 amended by adding Subsection (b-1) to read as follows:
- 15 (b-1) The state plan may include provisions to address
- 16 obesity treatment, education, and training related to:
- 17 (1) obesity-dependent diabetes; and
- 18 (2) the health impacts of obesity on a person with
- 19 diabetes.
- SECTION 6. Sections 103.014(a) and (c), Health and Safety
- 21 Code, are amended to read as follows:
- 22 (a) The council shall address contemporary issues affecting
- 23 health promotion services in the state, including:
- 24 (1) professional and patient education;
- 25 (2) evidence-based [successful] diabetes
- 26 self-management education strategies;
- 27 (3) evidence-based strategies to achieve the council's

- 1 mission [personnel preparation and continuing education];
- 2 (4) state expenditures for the prevention, detection,
- 3 management, and treatment of diabetes and obesity [chronic
- 4 diseases]; and
- 5 (5) [screening services; and
- 6 $\left[\frac{(6)}{(6)}\right]$ public awareness of the specific risks and
- 7 benefits of prevention, detection, management, and treatment of
- 8 <u>diabetes</u>, including obesity-dependent diabetes.
- 9 (c) The council may establish priorities and make
- 10 recommendations for program expenditures that align with the
- 11 <u>council's mission[</u>÷
- 12 [(1) compile and publish regional directories of
- 13 services for persons with diabetes;
- 14 [(2) design or adapt and publish a handbook in English
- 15 and Spanish relating to diet, exercise, and other self-care
- 16 management skills for persons with diabetes;
- 17 [(3) study the feasibility of a statewide hotline for
- 18 persons with diabetes; and
- 19 [(4) study the standards and structure of pilot
- 20 programs to provide diabetes education and training in this state].
- 21 SECTION 7. Sections 103.017(a) and (c), Health and Safety
- 22 Code, are amended to read as follows:
- 23 (a) The department, commission, and Texas Workforce
- 24 <u>Commission vocational rehabilitation services division</u> [Department
- 25 of Assistive and Rehabilitative Services | shall work with the
- 26 council to jointly develop, produce, and implement a general public
- 27 awareness strategy focusing on diabetes, its complications, and

- 1 techniques for achieving good management. Each agency shall pay
- 2 for the costs of producing and disseminating information on
- 3 diabetes to clients served by that agency.
- 4 (c) The department, commission, and Texas Workforce
- 5 Commission vocational rehabilitation services division [Department
- 6 of Assistive and Rehabilitative Services may jointly develop and
- 7 implement a statewide plan for conducting regional training
- 8 sessions for public and private service providers, including
- 9 institutional health care providers, who have routine contact with
- 10 persons with diabetes.
- 11 SECTION 8. Section 103.0175, Health and Safety Code, is
- 12 amended to read as follows:
- 13 Sec. 103.0175. MATERIALS FOR SCHOOL-BASED AND
- 14 SCHOOL-LINKED CLINICS. The council, in consultation with the
- 15 department and the Texas Education Agency, shall develop and make
- 16 available materials that provide information about diabetes to be
- 17 distributed to students and the parents of students by health
- 18 clinics at public primary or secondary schools.
- 19 SECTION 9. This Act takes effect September 1, 2019.
