- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Sections 27.001(2) and (6), Civil Practice and
- 6 Remedies Code, are amended to read as follows:
- 7 (2) "Exercise of the constitutional right to petition,
- 8 speak freely, or associate freely [of association]" means the
- 9 exercise of the right to petition, speak freely, or associate
- 10 freely as those rights are provided by the constitutions of this
- 11 state and the United States, as applied by the courts of this state
- 12 and the United States [a communication between individuals who join
- 13 together to collectively express, promote, pursue, or defend common
- 14 interests].
- 15 (6) "Legal action" means a lawsuit, cause of action,
- 16 petition, complaint, cross-claim, or counterclaim or any other
- 17 judicial pleading or filing that requests substantive relief,
- 18 regardless of whether the relief is legal or equitable [relief].
- 19 The term does not include:
- 20 (A) a motion or action related to discovery made
- 21 or taken under the Texas Rules of Civil Procedure, including a
- 22 motion to compel, or objection to, discovery, a motion seeking a
- 23 protective order related to discovery, or the issuance of a
- 24 subpoena;

- 1 (B) a motion for summary judgment;
- (C) a motion to dismiss a legal action under
- 3 Section 27.003;
- 4 (D) a procedure that relates to enforcement of a
- 5 final court order; or
- 6 (E) a motion for sanctions or award of attorney's
- 7 fees.
- 8 SECTION 2. Section 27.002, Civil Practice and Remedies Code,
- 9 is amended to read as follows:
- 10 Sec. 27.002. PURPOSE. The purpose of this chapter is to
- 11 provide a set of procedures to encourage and safeguard the
- 12 constitutional rights of persons to petition, speak freely,
- 13 associate freely, and otherwise participate in government to the
- 14 maximum extent permitted by law and, at the same time, protect the
- 15 rights of a person to file meritorious lawsuits for demonstrable
- 16 injury.
- 17 SECTION 3. Section 27.003(a), Civil Practice and Remedies
- 18 Code, is amended to read as follows:
- 19 (a) If a legal action is based on[, relates to,] or is in
- 20 response to a party's exercise of the constitutional right [of free
- 21 speech, right] to petition, speak freely, or associate freely
- 22 [right of association], that party may file a motion to dismiss the
- 23 legal action.
- SECTION 4. Section 27.004, Civil Practice and Remedies Code,
- 25 is amended by adding Subsections (d) and (e) to read as follows:
- 26 (d) A hearing on a motion to dismiss filed under this
- 27 chapter must be set not earlier than 21 days after service of the

- 1 motion.
- 2 (e) Each party must have at least 14 days' notice of a
- 3 hearing on a motion to dismiss filed under this chapter.
- 4 SECTION 5. Section 27.005, Civil Practice and Remedies Code,
- 5 is amended by amending Subsections (a), and (b), and adding
- 6 Subsection (e) to read as follows:
- 7 (a) Except as provided by Subsection (e), the [The] court
- 8 must rule on a motion under Section 27.003 not later than the 30th
- 9 day following the date of the hearing on the motion.
- 10 (b) Except as provided by Subsection (c), on the motion of a
- 11 party under Section 27.003, a court shall dismiss a legal action
- 12 against the moving party if the moving party shows by a
- 13 preponderance of the evidence that the legal action is based on,
- 14 [relates to,] or is in response to the party's exercise of the
- 15 constitutional right to petition, speak freely, or associate freely
- 16 [÷
- 17 [(1) the right of free speech;
- 18 [(2) the right to petition; or
- 19 [(3) the right of association].
- 20 (e) The court may not rule on a motion to dismiss filed under
- 21 this chapter if the responding party files a nonsuit of the
- 22 challenged legal action on or before the third day before the date
- 23 of the hearing on the motion.
- SECTION 6. Section 27.008, Civil Practice and Remedies Code,
- 25 is amended to read as follows:
- Sec. 27.008. APPEAL. (a) If a court does not rule on a
- 27 motion to dismiss under Section 27.003 in the time prescribed by

- 1 Section 27.005(a) [$\frac{27.005}{}$], the motion is considered to have been
- 2 denied by operation of law and the moving party may appeal.
- 3 (b) An appellate court shall expedite an appeal or other
- 4 writ, whether interlocutory or not, from a trial court order on a
- 5 motion to dismiss a legal action under Section 27.003 or from a
- 6 trial court's failure to rule on that motion in the time prescribed
- 7 by Section 27.005(a) [27.005].
- 8 SECTION 7. Section 27.009, Civil Practice and Remedies Code,
- 9 is amended by adding Subsection (c) to read as follows:
- 10 (c) The court may not award any costs, fees, expenses, or
- 11 sanctions for a motion to dismiss filed under this chapter if the
- 12 responding party nonsuited the challenged legal action in the time
- 13 prescribed by Section 27.005(e).
- SECTION 8. Section 27.010, Civil Practice and Remedies Code,
- 15 is amended to read as follows:
- Sec. 27.010. EXEMPTIONS. [(a)] This chapter does not apply
- 17 to<u>:</u>
- 18 (1) an enforcement action that is brought in the name of
- 19 this state or a political subdivision of this state by the attorney
- 20 general, a district attorney, a criminal district attorney, or a
- 21 county attorney;
- 22 (2) [(b) This chapter does not apply to] a legal action
- 23 brought against a person primarily engaged in the business of
- 24 selling or leasing goods or services, if the statement or conduct
- 25 arises out of the sale or lease of goods, services, or an insurance
- 26 product, insurance services, or a commercial transaction in which
- 27 the intended audience is an actual or potential buyer or customer;
