The term includes any activities related to or associated with an event. 16
- (a-2) Subsection (a-1)(1) of this section does not apply to 20 an event that is the largest event held each year at a sports 21 entertainment venue in this state with a permanent seating 22 23 capacity, including grandstand and premium seating, of not less than 125,000 as of September 1, 2019. If an endorsing municipality 24 or endorsing county requests the department to make a determination 25 26 under Subsection (b) of this section for an event described by this subsection, the provisions of this section apply to that event as if 27
