A BILL TO BE ENTITLED

AN ACT

2 relating to the confinement of a defendant pending trial and

3 detention or placement of a juvenile offender.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Chapter 17, Code of Criminal Procedure, is

6 amended by adding Article 17.154 to read as follows:

7 Art. 17.154. CONFINEMENT OF DEFENDANT DENIED BAIL. If a

8 judge or magistrate denies a defendant's release on bail pending

9 trial, the judge or magistrate shall order that the defendant be

10 confined in a jail that is located in this state.

11 SECTION 2. Article 17.27, Code of Criminal Procedure, is

12 amended to read as follows:

Art. 17.27. WHEN BAIL IS NOT PROVIDED [GIVEN]. If, after

14 the allowance of a reasonable period [time], the accused is unable

15 to provide the required bail bond [security be not given], the

16 magistrate shall [make an] order that [committing] the accused be

17 confined in a [to] jail that is located in this state [to be kept

18 safely until legally discharged; and he shall issue a commitment

19 accordingly].

SECTION 3. Section 51.12(j), Family Code, is amended to

21 read as follows:

22 (j) After being taken into custody, a child may be detained

23 in a secure detention facility located in this state until the child

24 is released under Section 53.01, 53.012, or 53.02 or until a

- 1 detention hearing is held under Section 54.01(a), regardless of
- 2 whether the facility has been certified under Subsection (c), if:
- 3 (1) a certified juvenile detention facility is not
- 4 available in the county in which the child is taken into custody;
- 5 (2) the detention facility complies with:
- 6 (A) the short-term detention standards adopted
- 7 by the Texas Juvenile Justice Department; and
- 8 (B) the requirements of Subsection (f); and
- 9 (3) the detention facility has been designated by the
- 10 county juvenile board for the county in which the facility is
- 11 located.
- 12 SECTION 4. Section 54.04, Family Code, is amended by
- 13 amending Subsection (d) and adding Subsection (d-1) to read as
- 14 follows:
- (d) <u>Subject to Subsection (d-1)</u>, if [If] the court or jury
- 16 makes the finding specified in Subsection (c) allowing the court to
- 17 make a disposition in the case:
- 18 (1) the court or jury may, in addition to any order
- 19 required or authorized under Section 54.041 or 54.042, place the
- 20 child on probation on such reasonable and lawful terms as the court
- 21 may determine:
- 22 (A) in the child's own home or in the custody of a
- 23 relative or other fit person; or
- 24 (B) subject to the finding under Subsection (c)
- 25 on the placement of the child outside the child's home, in:
- 26 (i) a suitable foster home;
- 27 (ii) a suitable public or private

- 1 residential treatment facility licensed by a state governmental
- 2 entity or exempted from licensure by state law, except a facility
- 3 operated by the Texas Juvenile Justice Department; or
- 4 (iii) a suitable public or private
- 5 post-adjudication secure correctional facility that meets the
- 6 requirements of Section 51.125, except a facility operated by the
- 7 Texas Juvenile Justice Department;
- 8 (2) if the court or jury found at the conclusion of the
- 9 adjudication hearing that the child engaged in delinquent conduct
- 10 that violates a penal law of this state or the United States of the
- 11 grade of felony, the court or jury made a special commitment finding
- 12 under Section 54.04013, and the petition was not approved by the
- 13 grand jury under Section 53.045, the court may commit the child to
- 14 the Texas Juvenile Justice Department under Section 54.04013[, or a
- 15 post-adjudication secure correctional facility under Section
- 16 $\frac{54.04011(c)(1)}{as applicable_{7}}$ without a determinate sentence;
- 17 (3) if the court or jury found at the conclusion of the
- 18 adjudication hearing that the child engaged in delinquent conduct
- 19 that included a violation of a penal law listed in Section 53.045(a)
- 20 and if the petition was approved by the grand jury under Section
- 21 53.045, the court or jury may sentence the child to commitment in
- 22 the Texas Juvenile Justice Department [or a post-adjudication
- 23 secure correctional facility under Section 54.04011(c)(2)] with a
- 24 possible transfer to the Texas Department of Criminal Justice for a
- 25 term of:
- 26 (A) not more than 40 years if the conduct
- 27 constitutes:

- 1 date the person was arrested, and the former law is continued in 2 effect for that purpose.
- (b) Sections 51.12 and 54.04, Family Code, as amended by 3 this Act, do not apply to the detention or placement of children in a facility in another state under an agreement entered into or 5 renewed before the effective date of this Act. An agreement for the 6 7 detention or placement of children in a facility in another state entered into or renewed before the effective date of this Act is 8 governed by the law in effect on the date the agreement was entered into or renewed, and the former law is continued in effect for that 10 11 purpose.
- 12 SECTION 6. This Act takes effect September 1, 2019.
