4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Subchapter B, Chapter 352, Tax Code, is amended

6 by adding Section 352.111 to read as follows:

7 Sec. 352.111. USE OF REVENUE; COUNTIES BORDERING PORTION OF

8 NECHES RIVER, SABINE RIVER, AND SABINE LAKE. (a) In addition to

the purposes authorized by this chapter, the revenue from a tax

10 imposed under this chapter by a county authorized to impose the tax

11 by Section 352.002(a)(28) may be used to construct and equip a

12 pavilion that is primarily used for events attended by tourists and

13 hotel guests and that has a substantial impact on hotel activity.

14 (b) If a county to which this section applies uses revenue

15 derived from the tax imposed under this chapter for a purpose

16 described by Subsection (a), the county may not reduce the

17 percentage of revenue from the tax imposed under this chapter and

18 allocated for a purpose described by Section 351.101(a)(3) to a

19 percentage that is less than the average percentage of that revenue

20 allocated by the county for that purpose during the 36-month period

21 preceding the date the county first uses hotel occupancy tax

22 revenue for the purpose described by Subsection (a).

23 SECTION 2. This Act takes effect immediately if it receives

24 a vote of two-thirds of all the members elected to each house, as
