- 4 (d) The term of an agreement under this section may not 5 exceed 40 years.
- 6 (e) An election required to authorize action under this 7 subchapter must be held in conformity with Chapter 1251, Government
- 8 Code, or other law applicable to the governmental entity.
- 9 The governing body of any governmental entity issuing bonds, notes, or other obligations or entering into agreements 10 11 under this section may exercise the authority granted to the governing body of an issuer with regard to issuance of obligations 12 13 under Chapter 1371, Government Code, except that the prohibition in that chapter on the repayment of an obligation with ad valorem taxes 14 15 does not apply to an issuer exercising the authority granted by this 16 section.
- 17 (g) An agreement under this section may contain repayment or 18 reimbursement obligations of an authority.
- SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2019.
