## A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to automatic voter registration of students enrolled in
- 3 public institutions of higher education.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter A, Chapter 13, Election Code, is
- 6 amended by adding Section 13.009 to read as follows:
- 7 Sec. 13.009. VOTER REGISTRATION THROUGH INSTITUTIONS OF
- 8 HIGHER EDUCATION. (a) The voter registrar of each county shall
- 9 automatically register any county resident who is eligible to vote
- 10 as provided by Section 13.001 and is enrolled in an institution of
- 11 <u>higher education as defined by Section 61.003</u>, Education Code.
- 12 (b) A student's application for enrollment in an
- 13 institution of higher education with an indication provided by
- 14 Section 20.133(b) that the enrollment is not for voter registration
- 15 purposes is not subject to this section.
- 16 <u>(c)</u> The secretary of state shall adopt rules and prescribe
- 17 procedures for the implementation of this section.
- SECTION 2. Section 20.001, Election Code, is amended by
- 19 adding Subsection (f) to read as follows:
- 20 <u>(f) Each institution of higher education, as defined by</u>
- 21 <u>Section 61.003</u>, <u>Education Code</u>, <u>is designated as a voter</u>
- 22 registration agency.
- SECTION 3. Chapter 20, Election Code, is amended by adding
- 24 Subchapter F to read as follows:

- 1 SUBCHAPTER F. INSTITUTIONS OF HIGHER EDUCATION
- 2 Sec. 20.131. DEFINITION. In this subchapter, "institution
- 3 of higher education" has the meaning assigned by Section 61.003,
- 4 Education Code.
- 5 Sec. 20.132. APPLICABILITY OF OTHER PROVISIONS. The other
- 6 provisions of this chapter apply to an institution of higher
- 7 <u>education except provisions that conflict with this subchapter or</u>
- 8 <u>Section 13.009.</u>
- 9 Sec. 20.133. REGISTRATION PROCEDURES. (a) An institution
- 10 of higher education shall consider each person of voting age who
- 11 enrolls at the institution an applicant for voter registration,
- 12 except as otherwise indicated by the person.
- 13 (b) An institution of higher education shall prescribe and
- 14 use a form and procedure that combines the institution's
- 15 application for enrollment with an officially prescribed voter
- 16 registration application form. The form and procedure must include
- 17 the option for an applicant to provide an appropriate address at the
- 18 time of enrollment in the institution. The form must allow an
- 19 applicant to indicate that the applicant does not wish the
- 20 applicant's enrollment to be used for voter registration purposes.
- 21 <u>(c) The design, content, and physical characteristics of</u>
- 22 the institution's forms must be approved by the secretary of state.
- Sec. 20.134. RULES. The secretary of state shall prescribe
- 24 additional procedures as necessary to implement this subchapter.
- 25 SECTION 4. This Act takes effect September 1, 2019.
