11 SECTION 3. Section 34.01, Tax Code, is amended by amending 12 Subsections (a), (b), (f), and (r) and adding Subsection (r-3) to 13 read as follows:

14 (a) Real or personal property seized under a tax warrant 15 issued under Subchapter <u>B or</u> E, Chapter 33, or ordered sold pursuant to a judgment for foreclosure of a tax lien shall be sold by the 16 17 officer charged with selling the property, unless otherwise directed by the taxing unit that requested the warrant or order of 18 19 sale or by an authorized agent or attorney for that unit. The sale shall be conducted in the manner similar property is sold under 20 execution except as otherwise provided by this subtitle. 21

(b) On receipt of an order of sale of real <u>or personal</u> property, the officer charged with selling the property shall endorse on the order the date and exact time when the officer received the order. The endorsement is a levy on the property without necessity for going upon the ground. The officer shall calculate the total amount due under the judgment, including all

taxes, penalties, and interest, plus any other amount awarded by 1 the judgment, court costs, and the costs of the sale. The costs of a 2 3 sale include the costs of advertising, and any deed recording fees anticipated to be paid in connection with the sale of the property. 4 5 To assist the officer in making the calculation, the collector of any taxing unit that is party to the judgment may provide the 6 officer with a certified tax statement showing the amount of the 7 8 taxes included in the judgment that remain due that taxing unit and all penalties, interest, and attorney's fees provided by the 9 10 judgment as of the date of the proposed sale. If a certified tax statement is provided to the officer, the officer shall rely on the 11 12 amount included in the statement and is not responsible or liable for the accuracy of the applicable portion of the calculation. 13 Α 14 certified tax statement is not required to be sworn to and is 15 sufficient if the tax collector or the collector's deputy signs the 16 statement.

17 (f) A notice of sale <u>of real property</u> is not required to 18 include field notes describing the property. A description of the 19 property is sufficient if the notice:

20 (1) states the number of acres and identifies the21 original survey;

(2) as to property located in a platted subdivision or
addition, regardless of whether the subdivision or addition is
recorded, states the name by which the land is generally known with
reference to that subdivision or addition; or

26 (3) by reference adopts the description of the27 property contained in the judgment.

1 (r) Except as provided by Subsection (a-1) and this subsection, a sale of real property under this section must take 2 3 place at the county courthouse in the county in which the real property [land] is located. The commissioners court of the county 4 may designate an area other than an area at the county courthouse 5 where sales under this section will take place that is in a public 6 place within a reasonable proximity of the county courthouse as 7 8 determined by the commissioners court and in a location as accessible to the public as the courthouse door. The commissioners 9 10 court shall record that designation in the real property records of the county. A designation by a commissioners court under this 11 section is not a ground for challenging or invalidating any sale. A 12 sale must be held at an area designated under this subsection if the 13 14 sale is held on or after the 90th day after the date the designation 15 is recorded.

16 (r-3) Notwithstanding Subsection (r), the sale of personal 17 property, including a manufactured home, may be conducted at the 18 same place as the sale of real property under Subsection (r) or at 19 the location of the personal property.

SECTION 4. Section 33.56, Tax Code, as amended by this Act, applies only to a petition to vacate a judgment for foreclosure of a tax lien that is filed under that section on or after the effective date of this Act. A petition to vacate a judgment for foreclosure of a tax lien that is filed before the effective date of this Act is governed by the law in effect on the date the petition is filed, and the former law is continued in effect for that purpose.

27 SECTION 5. This Act takes effect immediately if it receives

a vote of two-thirds of all the members elected to each house, as
 provided by Section 39, Article III, Texas Constitution. If this
 Act does not receive the vote necessary for immediate effect, this
 Act takes effect September 1, 2019.
