- 23 delegating and assigning the performance of therapeutic and

- 26 Section 301.358, prescribing, ordering, procuring, administering,
- 27 and dispensing drugs and devices, including blood and blood

- 1 products, controlled substances listed in Schedules II, III, IV,

- 5 (7) serving as the primary care provider of record;

- 12 (c) An advanced practice registered nurse authorized to

- 17 (d) An advanced practice registered nurse authorized to
- 18 practice by the board under this section is accountable to
- 19 patients, the nursing profession, and the board for:
- 20 (1) complying with the requirements of this chapter;
- 21 (2) providing quality advanced nursing care;
- 22 (3) recognizing the nurse's limits of knowledge;
- 23 (4) planning for the management of situations beyond
- 24 the nurse's expertise; and
- 25 (5) consulting with or referring patients to other
- 26 health care providers as appropriate.
