- 1 SECTION 2. Not later than October 1, 2019, the lieutenant
- 2 governor and the speaker of the house of representatives shall
- 3 appoint the members of the Medicaid Waiver Renewal Legislative
- 4 Oversight Committee as required by Section 531.172(c), Government
- 5 Code, as added by this Act.
- 6 SECTION 3. This Act takes effect immediately if it receives
- 7 a vote of two-thirds of all the members elected to each house, as
- 8 provided by Section 39, Article III, Texas Constitution. If this
- 9 Act does not receive the vote necessary for immediate effect, this
- 10 Act takes effect September 1, 2019.
