- Subject: Duty #4 Evaluate the ongoing and long term workforce needs of the state related to cyber security, mental health, law enforcement and related professionals.

Following the supreme court's 1962 and 1963 decisions to abolish the reading of the Holy Bible and prayer in schools; this great nation has been in moral decline ever since. The marked increase in crime is evident (see:
