Senator Nelson sent up a committee substitute. The chair recognized Senator Nelson to explain the difference between the committee substitute and the senate bill as filed.

Senator Nelson sent up Committee Amendment 1 and moved adoption; without objection, the amendment was adopted.

Senator Nelson requested unanimous consent to incorporate Committee Amendment 1 into the committee substitute; without objection, it was so ordered. Senator Nelson then moved that the committee substitute be adopted; without objection, it was so ordered.

Senator Watson moved to reconsider the vote by which the committee substitute was adopted; without objection, it was so ordered.

Senator Watson sent up Committee Amendment 2 and moved adoption; without objection, the amendment was adopted.

Senator Watson requested unanimous consent to incorporate Committee Amendment 2 into the committee substitute; without objection, it was so ordered. Senator Watson then moved that the committee substitute be adopted; without objection, it was so ordered.

Public testimony continued on SB 3.

The chair moved that the public testimony be closed; without objection, it was so ordered.

Senator Nelson moved that SB 3 do not pass but that CSSB 3 be reported back to the Senate with the recommendation that it do pass and be printed. The motion carried with a record vote of 15 ayes, 0 nays, 0 present not voting, and 0 absent.
