You are hereby notified that the building located at the above-reference unfit for human use or habitation or is obsolete, dilapidated, or substandard, a Chapter 18 of the Code of Ordinances of the City of Baytown. As such, a public hearing will be held on **January 22, 2019 at 1:00 p.m. in the Municipal Court, located at 3 Baytown, Harris County, Texas 77521.** At this hearing, the owners, lienholders will be required and have the burden to prove that the building is in compliance with the City of Baytown. If the owners, lienholders, or mortgagees request to bring compliance, a scope of any work required showing compliance with such ordinance detailing the time it will take to reasonably perform the work must be submitted.

After considering all of the evidence presented at the hearing, the Municipality shall issue an order. Such order may require that the building be secured, repaired, demolished by the owners, mortgagees, and/or lienholders within a reasonable time to secure or demolish the building issued by the Court are not fulfilled by the owners or mortgagees as ordered, said directives shall be performed by the City. If the City's costs incurred by the City to accomplish the order will be billed to the owners, or mortgagees. If the bill remains unpaid after the expiration of thirty days following the order, a lien will be filed against the subject property to ensure further collection.
