

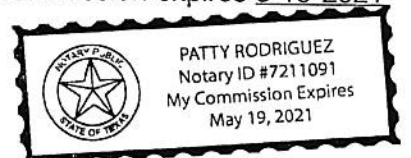

NOTICE OF INTENT TO INTRODUCE A BILL

Pursuant to the Constitution and laws of the State of Texas, notice is hereby given of the intention to apply to the 86th Legislature of the State of Texas at its regular session in Austin, Texas for the introduction of a bill, the substance of which is the contemplated law being as follows: An Act relating to the creation of the Clear Fork Ranch Municipal Utility District providing the authority to impose a tax and issue bonds.

The Act proposes to create a conservation and reclamation district to be known as Clear Fork Ranch Municipal Utility District being two tracts of land encompassing approximately 472.126 acres in Caldwell County, Texas, a portion of which is located in the extrajurisdiction of the City of Lockhart, Texas, and the remainder of which is located in the unincorporated territory of Caldwell County. The proposed district is located south and adjacent to State Highway 142 approximately 1.5 miles west of State Highway 130.

The District's creation is subject to approval at a confirmation election. All interested persons will, therefore, take notice of the matters and facts set out in the foregoing statement of the substance of the contemplated laws as required by the Constitution and laws of the State of Texas.
