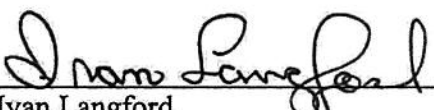


AFFIDAVIT OF IVAN LANGFORD

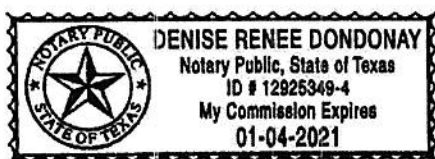
