

In accordance with Article 116.022 of the Texas Local Government Code,

NOTICE, is hereby given to any Chambers County banking corporation, or individual banker, that the Chambers County Comptroller of Public Accounts, on **10:00 a.m.** on the **23rd** day of **April, 2019**, select one or more banks for the following Chambers County Funds:

- Chambers County Operating Funds
- Interest and Sinking Funds
- District and County Clerk Trust Funds
- County Permanent School Funds
- County Internal Funds
- Other Related Funds

The county reserves the right to withdraw any or all Chambers County School Funds from this depository agreement. It is understood that the County Treasurer would give a 30-day written notice prior to the withdrawal of these funds.

The term of the depository contract shall be **four, (4) years** and shall be reviewed at the end of **two, (2) years**.

Any banking corporation, association or individual banker acting as a County Depository shall make and deliver to the County Comptroller of Public Accounts an application applying for such contract on or before **2:00 p.m.** of **April, 2019**. The application must be in a sealed envelope and labeled **"Depository Application."**

The application must state the amount of the bank's paid-in capital and permanent surplus; the application must be accompanied by:

(1) A statement showing the financial condition of the bank as of the date of the application;

and

(2) A certified check or cashier's check for at least one-half of the county's revenue for the preceding year.

The certified check or cashier's check that accompanies the application shall have a faith guarantee on the part of the applicant that if accepted by the county it will execute the bond required under Ch. 116, Subchapter C, Government Code. If the bank is selected as a depository under this bond, the county shall retain the amount of the check as
