

McCutchen (H. & T.C. R.R. Co.) Survey, Abstract No. 312; H. & T.C. R.R. Co. Survey, Abstract No. 145; W. McCutchen (H. & T.C. R.R. Co.) Survey, Abstract No. 315; H. & T.C. R.R. Co. Survey, Abstract No. 193; W. McCutchen (H. & T.C. R.R. Co.) Survey, Abstract No. 309; H. & T.C. R.R. Co. Survey, Abstract No. 192; H. & T.C. R.R. Co. Survey, Abstract No. 188; J. McCutchen (H. & T.C. R.R. Co.) Survey, Abstract No. 307; and the E. Wright (H. & T.C. R.R. Co.)
