Relating to access to services in an area annexed by a tier 1 municipality under a service plan.

Relating to the authority of a county to require a person to obtain a building permit from the county for certain portable structures.

Relating to issues affecting counties and other political subdivisions of the state.

Relating to the creation of the New Park Municipal Management District; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes.

Relating to the creation of the SoGood Cedars Municipal Management District; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes.

SB 2518

Alvarado

Relating to the creation of the East Houston Management District; providing authority to issue bonds; providing authority to impose assessments, fees, or taxes.

SB 2520

Bettencourt

Relating to the powers and duties of the Cy-Champ Public Utility District; providing authority to issue bonds; providing authority to impose a tax.

SB 2530

Fallon

Relating to the creation of the Van Alstyne Municipal Utility District No. 2 of Collin County; granting a limited power of eminent domain; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes.

SB 2535

Fallon

Relating to the powers and duties of the Lakehaven Municipal Utility District; providing authority to issue bonds; providing authority to impose a tax.
