8	Sec. 39.0552. CERTAIN STUDENTS RECEIVING RESIDENTIAL
9	SERVICES IN STATE HOSPITALS NOT CONSIDERED FOR ACCOUNTABILITY
10	PURPOSES. Notwithstanding any other provision of this code, in
11	determining the performance of a school district or campus under
12	this chapter, a student receiving residential services in a state
13	hospital is not considered a student of the school district or
14	campus in which the state hospital is physically located.
15	SECTION 2. This Act takes effect immediately if it receives
16	a vote of two-thirds of all the members elected to each house, as
17	provided by Section 39, Article III, Texas Constitution. If this
18	Act does not receive the vote necessary for immediate effect, this

Act takes effect September 1, 2019.

A 5 memorandum of understanding between a school district and a state 6 hospital under which the district provides educational services to 7 a student who resides in the state hospital must provide that the 8 school district include the performance of the student on an 9 assessment instrument or other achievement indicator adopted under 10 Section 39.053 or a reporting indicator adopted under Section 11
