18 received by an educator shall be recorded on the agency's Educator  
19 Certification Online System (ECOS) and included as part of the  
20 educator's public certification records.

21 SECTION 2. This Act takes effect immediately if it receives  
22 a vote of two-thirds of all the members elected to each house, as  
23 provided by Section 39, Article III, Texas Constitution. If this  
24 Act does not receive the vote necessary for immediate effect, this
