5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Subchapter A, Chapter 182, Health and Safety
7 Code, is amended by adding Section 182.004 to read as follows:

8 Sec. 182.004. APPLICATION OF SUNSET ACT. The Texas Health
9 Services Authority is subject to Chapter 325, Government Code
10 (Texas Sunset Act). Unless continued in existence as provided by
11 that chapter, the corporation is abolished and this section,
12 Section 182.001, and Subchapters B and C expire September 1, 2027.

13 SECTION 2. The following provisions of the Health and
14 Safety Code are repealed:

- 15 (1) Section 182.003;
16 (2) Section 182.052;
17 (3) Section 182.101(b);
18 (4) Section 182.102(c);
19 (5) Section 182.103(d);
20 (6) Section 182.104(b);
21 (7) Section 182.105(b);
22 (8) Section 182.106(b);
23 (9) Section 182.107(d); and
24 (10) Section 182.108(f).

1 SECTION 3. Section 15(b), Chapter 12 (S.B. 203), Acts of the
