H.B. No. 4182

A BILL TO BE ENTITLED

AN ACT

relating to an intercollegiate athletics fee at the University of North Texas at Dallas.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subchapter E, Chapter 54, Education Code, is amended by adding Section 54.5192 to read as follows:

Sec. 54.5192. INTERCOLLEGIATE ATHLETICS FEE; UNIVERSITY OF NORTH TEXAS AT DALLAS. (a) The board of regents of the University of North Texas System may charge each student enrolled at the University of North Texas at Dallas an intercollegiate athletics fee in an initial amount not to exceed \$10 per semester credit hour for each regular semester or summer session. The amount of the fee may be increased only as provided by Subsection (e).

(b) A student enrolled in more than 12 semester credit hours shall pay the fee in an amount equal to the amount charged a student enrolled in 12 semester credit hours during the same semester or session.

(c) Revenue from the fee charged under this section may be used only to develop and maintain an intercollegiate athletics program at the university.

(d) The fee may not be charged unless approved by a majority vote of the students enrolled at the university who participate in a general student election held for that purpose.

(e) The amount of the fee per semester credit hour may be

1 increased from one academic year to the next only if approved by a  
2 majority vote of the students participating in a general student  
3 election held for that purpose or, if the amount of the increase  
4 does not exceed five percent, by a majority vote of the legislative  
5 body of the student government of the university.

6 (f) A fee charged under this section is in addition to any  
7 other fee authorized by law and may not be considered in determining  
8 the maximum amount of student services fees that may be charged each  
9 student enrolled at the university under Section 54.503.

10 SECTION 2. A fee may not be charged under Section 54.5192,  
11 Education Code, as added by this Act, before the 2019 fall semester.

12 SECTION 3. This Act takes effect immediately if it receives  
13 a vote of two-thirds of all the members elected to each house, as  
14 provided by Section 39, Article III, Texas Constitution. If this  
15 Act does not receive the vote necessary for immediate effect, this  
16 Act takes effect September 1, 2019.

(b) A student enrolled in more than 12 semester credit hours  
shall pay the fee in an amount equal to the amount charged a student  
enrolled in 12 semester credit hours during the same semester or  
session.

(c) Revenue from the fee charged under this section may be  
used only to develop and maintain an intercollegiate athletics  
program at the university.

(d) The fee may not be charged unless approved by a majority  
vote of the students enrolled at the university who participate in a  
general student election held for that purpose.

(e) The amount of the fee per semester credit hour may be

1 increased from one academic year to the next only if approved by a  
2 majority vote of the students participating in a general student  
3 election held for that purpose or, if the amount of the increase  
4 does not exceed five percent, by a majority vote of the legislative  
5 body of the student government of the university.

6 (f) The ballot proposition for an election to approve a  
7 proposed initial fee under Subsection (d) or a proposed fee  
8 increase under Subsection (e) must:

9 (1) clearly state the amount of the proposed fee or fee  
10 increase, as applicable; and

11 (2) describe the reason for the proposed fee or fee  
12 increase, as applicable.

13 (g) A fee charged under this section is in addition to any  
14 other fee authorized by law and may not be considered in determining  
15 the maximum amount of student services fees that may be charged each  
16 student enrolled at the university under Section 54.503.

17 SECTION 2. A fee may not be charged under Section 54.5192,  
18 Education Code, as added by this Act, before the 2019 fall semester.

19 SECTION 3. This Act takes effect immediately if it receives  
20 a vote of two-thirds of all the members elected to each house, as  
21 provided by Section 39, Article III, Texas Constitution. If this  
22 Act does not receive the vote necessary for immediate effect, this  
23 Act takes effect September 1, 2019.
