4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 12, Election Code, is
6	amended by adding Section 12.007 to read as follows:
7	Sec. 12.007. CERTAIN ELECTION OFFICERS ARE VOTER
8	REGISTRARS. The registrar shall appoint at least one election
9	officer serving each polling place for early voting by personal
10	appearance or on election day as a regular deputy registrar.
11	SECTION 2. Chapter 63, Election Code, is amended by adding
12	Section 63.010 to read as follows:
13	Sec. 63.010. REGISTRATION AT POLLING PLACE; VOTING
14	PROCEDURES. (a) Other applicable provisions of this code apply to
15	the conduct of voting and to the registration of voters under this
16	section to the extent those provisions do not conflict with this
17	section.
18	(b) A person who would be eligible to vote in an election
19	under Section 11.001, but for the requirement to be a registered
20	voter, shall be accepted for voting at a polling place at which the
21	person would be allowed to vote if registered if, on the day the
22	person offers to vote, the person:
23	(1) submits a voter registration application that
24	complies with Section 13.002 to a voter registrar at the polling

2	(2) presents as proof of identification:
3	(A) a Texas driver's license, including a
4	temporary license or instruction permit, or personal
5	identification card issued to the person by the Department of
6	Public Safety that states the person's current address on the day
7	the person seeks to vote; or
8	(B) a utility bill addressed to the person dated
9	not earlier than the 30th day before the date the person seeks to
10	vote, and:
11	(i) a Texas driver's license, including a
12	temporary license or instruction permit, or personal
13	identification card issued to the person by the Department of
14	Public Safety, regardless of whether the address stated on the
15	license or card is current on the day the person seeks to vote;
16	(ii) a United States passport issued to the
17	person; or
18	(iii) a United States military
19	identification card that contains the person's photograph; and
20	(3) executes an affidavit stating that the person:
21	(A) is eligible to vote in the election; and
22	(B) is voting only once in the election.
23	(c) Persons voting under this section shall be processed
24	separately at the polling place from persons who are voting under
25	regular procedures.
26	(d) The secretary of state shall adopt rules to ensure the
27	accountability of election officers and to fairly implement this

2 SECTION 3. Section 85.031(a), Election Code, is amended to 3 read as follows:

4 (a) For each person entitled to vote an early voting ballot
5 by personal appearance or who is entitled to register at a polling
6 place, the early voting clerk shall follow the procedure for
7 accepting a regular voter on election day, with the modifications
8 necessary for the conduct of early voting.

9 SECTION 4. The secretary of state shall adopt rules as 10 required by Section 63.010, Election Code, as added by this Act, not 11 later than February 1, 2022.

12 SECTION 5. The changes in law made by this Act apply only to 13 an election for which early voting by personal appearance begins on 14 or after February 1, 2022.

15 SECTION 6. This Act takes effect immediately if it receives 16 a vote of two-thirds of all the members elected to each house, as 17 provided by Section 39, Article III, Texas Constitution. If this 18 Act does not receive the vote necessary for immediate effect, this 19 Act takes effect on the 91st day after the last day of the 20 legislative session.
