18	business owner may bring an action against a governmental entity

21	(b) An action under this chapter may be brought in a
22	district court in any county in which the business is located.

24	TO SUE. (a) Sovereign and governmental immunity to suit and from
25	liability is waived and abolished to the extent of liability
26	created by this chapter.
