A BILL TO BE ENTITLED

- 2 relating to requiring a voter to present proof of identification.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 13.002(i), Election Code, is amended to
- 5 read as follows:
- 6 (i) An applicant who wishes to receive an exemption from the
- 7 requirements of Section 63.001(b) on the basis of disability must
- 8 include with the person's application:
- 9 (1) written documentation:
- 10 (A) from the United States Social Security
- 11 Administration evidencing the applicant has been determined to have
- 12 a disability; or
- 13 (B) from the United States Department of Veterans
- 14 Affairs evidencing the applicant has a disability rating of at
- 15 least 50 percent; and
- 16 (2) a statement in a form prescribed by the secretary
- 17 of state that the applicant does not have [a form of] identification
- 18 required by Section 63.001(b) in a form described by [acceptable
- 19 <u>under</u>] Section 63.0101.
- SECTION 2. Sections 63.001(b) and (i), Election Code, are
- 21 amended to read as follows:
- 22 (b) Except as provided by Subsection (h), on offering to
- 23 vote, a voter must present to an election officer at the polling
- 24 place:

- 1 (1) one form of photo identification listed in Section
- 2 63.0101(a); [or]
- 3 (2) one form of identification listed in Section
- 4 63.0101(b)(1), (2), or (3) accompanied by the declaration described
- 5 by Subsection (i);
- 6 (3) two forms of identification listed under Section
- 7 63.0101(b), including one form that contains the voter's current
- 8 address; or
- 9 (4) two forms of identification listed under Section
- 10 63.0101(b)(4) accompanied by the declaration described by
- 11 Subsection (i) of this section.
- 12 (i) If the requirement for identification prescribed by
- 13 Subsection (b)(1) or (3) is not met, an election officer shall
- 14 notify the voter that the voter may be accepted for voting if the
- 15 voter meets the requirement for identification prescribed by
- 16 Subsection (b)(2) or (4) and executes a declaration declaring the
- 17 voter has a reasonable impediment to meeting the requirement for
- 18 identification prescribed by Subsection (b)(1) or (3). A person is
- 19 subject to prosecution for perjury under Chapter 37, Penal Code, or
- 20 Section 63.0013 for a false statement or false information on the
- 21 declaration. The secretary of state shall prescribe the form of the
- 22 declaration. The form shall include:
- 23 (1) a notice that a person is subject to prosecution
- 24 for perjury under Chapter 37, Penal Code, or Section 63.0013 for a
- 25 false statement or false information on the declaration;
- 26 (2) a statement that the voter swears or affirms that
- 27 the information contained in the declaration is true, that the

- 1 person described in the declaration is the same person appearing at
- 2 the polling place to sign the declaration, and that the voter faces
- 3 a reasonable impediment to procuring the identification prescribed
- 4 by Subsection (b)(1) or (3);
- 5 (3) a place for the voter to indicate one of the
- 6 following impediments:
- 7 (A) lack of transportation;
- 8 (B) lack of birth certificate or other documents
- 9 needed to obtain the identification prescribed by Subsection
- 10 (b)(1);
- 11 (C) work schedule;
- 12 (D) lost or stolen identification;
- 13 (E) disability or illness;
- 14 (F) family responsibilities; and
- 15 (G) the identification prescribed by Subsection
- 16 (b)(1) or (3) has been applied for but not received;
- 17 (4) a place for the voter to sign and date the
- 18 declaration;
- 19 (5) a place for the election judge to sign and date the
- 20 declaration;
- 21 (6) a place to note the polling place at which the
- 22 declaration is signed; and
- 23 (7) a place for the election judge to note which form
- 24 of identification prescribed by Subsection (b)(2) or (4) the voter
- 25 presented.
- SECTION 3. Sections 63.0101(a) and (b), Election Code, are
- 27 amended to read as follows:

- 1 (a) The following documentation is an acceptable form of 2 photo identification under this chapter:
- 3 (1) a driver's license, election identification
- 4 certificate, or personal identification card issued to the voter
- 5 [person] by the Department of Public Safety that has not expired or
- 6 that expired no earlier than four years before the date of
- 7 presentation;
- 8 (2) a United States military identification card that
- 9 contains the voter's [person's] photograph that has not expired or
- 10 that expired no earlier than four years before the date of
- 11 presentation;
- 12 (3) a United States citizenship certificate issued to
- 13 the voter [person] that contains the voter's [person's] photograph;
- 14 (4) a United States passport book or card issued to the
- 15 voter [person] that has not expired or that expired no earlier than
- 16 four years before the date of presentation; [or]
- 17 (5) a license to carry a handgun issued to the voter
- 18 [person] by the Department of Public Safety that has not expired or
- 19 that expired no earlier than four years before the date of
- 20 presentation;
- 21 (6) an official Native American tribal document that:
- (A) contains the voter's photograph and address;
- 23 <u>and</u>
- 24 (B) is issued by a tribe that is federally
- 25 recognized and located in this state; or
- 26 (7) any other official government document issued to
- 27 the voter and containing the voter's name, address, and photograph.

- 13 (1) a space for entering the identification number of
- 14 the provisional ballot voted by the person; and
- 15 (2) a space for an election officer to indicate
- 16 whether the person presented [a form of] identification required by
- 17 Section 63.001(b) in a form described by Section 63.0101.
- SECTION 5. Section 65.0541(a), Election Code, is amended to
- 19 read as follows:
- 20 (a) A voter who is accepted for provisional voting under
- 21 Section 63.011 because the voter does not meet the identification
- 22 requirements of Section 63.001(b) may, not later than the sixth day
- 23 after the date of the election:
- 24 (1) present [a form of] identification required by
- 25 Section 63.001(b) in a form described by Section 63.0101 to the
- 26 voter registrar for examination; or
- 27 (2) execute an affidavit described by Section

1 65.054(b)(2)(B) or (C) in the presence of the voter registrar.
```

- 2 SECTION 6. Section 86.006(a-1), Election Code, is amended
- 3 to read as follows:
- 4 (a-1) The voter may deliver a marked ballot in person to the
- 5 early voting clerk's office only while the polls are open on
- 6 election day. A voter who delivers a marked ballot in person must
- 7 present identification required by Section 63.001(b) in a [an
- 8 acceptable] form [of identification] described by Section 63.0101.
- 9 SECTION 7. This Act takes effect on the 91st day after the
- 10 last day of the legislative session.
