## A BILL TO BE ENTITLED

Τ	AN ACT
2	relating to a study by the Texas Division of Emergency Management of
3	the potential effects of droughts and wildfires in this state.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. DEFINITION. In this Act, "division" means the
6	Texas Division of Emergency Management.
7	SECTION 2. STUDY. (a) The division shall conduct a study
8	regarding the potential effects of droughts and wildfires in this
9	state over the next 50 years. The study must include an assessment
10	of:
11	(1) the projected ecological effects of droughts and
12	wildfires, including:
13	(A) harm to plants, animals, and water bodies;
14	and
15	(B) damage to state parks and other public lands;
16	(2) the projected effects of droughts on the
17	temperature in urban areas, including:
18	(A) increases in the demand for energy and water;
19	(B) demands on public health facilities;
20	(C) any decline in business productivity; and
21	(D) any decline in tourism;
22	(3) the projected economic effects of droughts and
23	wildfires, including:
24	(A) agricultural losses; and

- 1 (B) damage to infrastructure;
- 2 (4) vulnerabilities to droughts and wildfires;
- 3 (5) the availability of local resources to combat
- 4 wildfires and adapt to droughts; and
- 5 (6) potential mitigation strategies for reducing the
- 6 risk of and damage caused by droughts and wildfires.
- 7 (b) In conducting the study, the division shall solicit and
- 8 consider information from:
- 9 (1) the Department of Public Safety;
- 10 (2) the Department of Agriculture;
- 11 (3) the Parks and Wildlife Department;
- 12 (4) the Texas Commission on Environmental Quality; and
- 13 (5) other agencies, municipalities, and environmental
- 14 organizations as necessary.
- SECTION 3. REPORT. Not later than November 1, 2022, the
- 16 division shall submit to the governor, the lieutenant governor, the
- 17 speaker of the house of representatives, and each standing
- 18 committee of the legislature with primary jurisdiction over the
- 19 division, the Department of Public Safety, the Department of
- 20 Agriculture, the Parks and Wildlife Department, and the Texas
- 21 Commission on Environmental Quality a written report that includes
- 22 a summary of the study and any legislative recommendations based on
- 23 the study.
- SECTION 4. EXPIRATION. This Act expires January 1, 2023.
- 25 SECTION 5. EFFECTIVE DATE. This Act takes effect
- 26 immediately if it receives a vote of two-thirds of all the members
- 27 elected to each house, as provided by Section 39, Article III, Texas

- 1 Constitution. If this Act does not receive the vote necessary for
- 2 immediate effect, this Act takes effect on the 91st day after the
- 3 last day of the legislative session.
