- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter A, Chapter 12, Election Code, is
- 6 amended by adding Section 12.007 to read as follows:
- 7 Sec. 12.007. CERTAIN ELECTION OFFICERS ARE VOTER
- 8 REGISTRARS. The registrar shall appoint at least one election
- 9 officer serving each polling place for early voting by personal
- 10 appearance or on election day as a regular deputy registrar.
- 11 SECTION 2. Chapter 63, Election Code, is amended by adding
- 12 Section 63.010 to read as follows:
- 13 Sec. 63.010. REGISTRATION AT POLLING PLACE; VOTING
- 14 PROCEDURES. (a) Other applicable provisions of this code apply to
- 15 the conduct of voting and to the registration of voters under this
- 16 section to the extent those provisions do not conflict with this
- 17 section.

- 18 (b) A person who would be eligible to vote in an election
- 19 under Section 11.001, but for the requirement to be a registered
- 20 voter, shall be accepted for voting in the precinct of the person's
- 21 residence if, on the day the person offers to vote, the person:
- (1) submits a voter registration application that
- 23 complies with Section 13.002 to a voter registrar at the polling
- 24 place; and

1 (2) presents as proof of identification: 2 (A) a Texas driver's license, including a temporary license or instruction permit, or personal 3 identification card issued to the person by the Department of 4 5 Public Safety that states the person's current address on the day the person seeks to vote; or 6 7 (B) a utility bill addressed to the person dated not earlier than the 30th day before the date the person seeks to 8 vote, and: 9 10 (i) a Texas driver's license, including a temporary license or instruction permit, or personal 11 12 identification card issued to the person by the Department of Public Safety, regardless of whether the address stated on the 13 14 license or card is current on the day the person seeks to vote; 15 (ii) a United States passport issued to the 16 person; or 17 (iii) a United States military identification card that contains the person's photograph. 18 19 (c) Persons voting under this section shall be processed separately at the polling place from persons who are voting under 20 regular procedures. 21 (d) The secretary of state shall adopt rules to ensure the 22 accountability of election officers and to fairly implement this 23 24 section. SECTION 3. Section 85.031(a), Election Code, is amended to 25

- 1 by personal appearance or entitled to register at a polling place,
- 2 the early voting clerk shall follow the procedure for accepting or
- 3 <u>registering</u> a regular voter on election day, with the modifications
- 4 necessary for the conduct of early voting.
- 5 SECTION 4. The secretary of state shall adopt rules as
- 6 required by Section 63.010, Election Code, as added by this Act, not
- 7 later than February 1, 2022.
- 8 SECTION 5. The changes in law made by this Act apply only to
- 9 an election for which early voting by personal appearance begins on
- 10 or after February 1, 2022.
- 11 SECTION 6. This Act takes effect on the 91st day after the
- 12 last day of the legislative session.
