2	relating to waivers for entrance fees to state parks for resident
3	first responders, military service members, and veterans.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 13.015, Parks and Wildlife Code, is
6	amended by amending Subsection (a-2) and adding Subsections (a-3)
7	and (a-4) to read as follows:
8	(a-2) The department shall waive the park entrance fee for a
9	resident of this state who is a first responder. In this
10	subsection, "first responder" means a person who is:
11	(1) a firefighter certified by the Texas Commission on
12	Fire Protection or by the State Firefighters' and Fire Marshals'
13	Association of Texas;
14	(2) an individual certified as emergency medical
15	services personnel by the Department of State Health Services;
16	(3) a municipal police officer;
17	(4) a sheriff, deputy sheriff, or reserve deputy
18	sheriff; or
19	(5) a constable, deputy constable, or reserve deputy
20	constable.
21	(a-3) The department shall waive the park entrance fee for
22	an active duty member or veteran of the armed services of the United

Guard, or the Texas State Guard.

- 1 (a-4) The department may promote visits and enhance revenue
- 2 at parks, including amounts necessary for salaries, advertising,
- 3 consumable supplies and materials, promotional products, fees, and
- 4 related expenses.
- 5 SECTION 2. Sections 13.018(a), (c), and (e), Parks and
- 6 Wildlife Code, are amended to read as follows:
- 7 (a) The following people may apply to the department for a
- 8 state parklands passport:
- 9 (1) a resident of this state who is 65 years old or
- 10 over who has resided in the state for six consecutive months
- 11 preceding the date of application for a parklands passport $[\frac{1}{2}]$
- 12 member of the United States armed forces on active duty who is 65
- 13 years old or over, or any other individual in a category that the
- 14 commission by rule designates as a resident of this state who is 65
- 15 years old or over; and
- 16 (2) [a veteran of the armed services of the United
- 17 States who, as a result of military service, has a
- 18 service-connected disability, as defined by the Veterans'
- 19 Administration, consisting of the loss of the use of a lower
- 20 extremity or of a 60 percent disability rating and who is receiving
- 21 compensation from the United States because of the disability; and
- [(3)] an individual who has a physical or mental
- 23 impairment that substantially limits one or more of the major life
- 24 activities of the individual.
- 25 (c) The holder of a state parklands passport issued on or
- 26 before August 31, 1995, or a person whose birth date is before
- 27 September 1, 1930, [or a veteran described by Subsection (a)(2)] is

- 1 entitled to enter any state park without payment of an entrance or
- 2 admission fee. When a fee is charged by the department for entrance
- 3 of a vehicle into a state park, the vehicle of the holder of a state
- 4 parklands passport is exempt from the fee when the holder is
- 5 present.
- 6 (e) The commission by rule shall establish eligibility
- 7 requirements and privileges available to the holder of a state
- 8 parklands passport described by Subsection (a)(2) [(a)(3)].
- 9 SECTION 3. This Act takes effect on the 91st day after the
- 10 last day of the legislative session.
