- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 212.009, Local Government Code, is
- 6 amended by adding Subsection (a-1) to read as follows:
- 7 (a-1) Unless specifically authorized by another law of this
- 8 state, a municipal planning commission or the governing body of the
- 9 municipality may not:
- 10 (1) require a person to fulfill any prerequisites or
- 11 conditions or obtain any approvals before the person files a copy of
- 12 the plan or plat with the municipal planning commission or
- 13 governing body;
- 14 (2) delay the starting date for calculating any
- 15 applicable timeframe under this chapter to approve or disapprove a
- 16 plan or plat by not considering the date the plan or plat was filed
- 17 as the starting date; or
- 18 (3) refuse to accept, acknowledge, process, or act on
- 19 <u>a filed copy of the plan or plat.</u>
- SECTION 2. The heading to Section 232.00285, Local
- 21 Government Code, is amended to read as follows:
- Sec. 232.00285. APPROVAL PROCEDURE: LIMITATIONS ON COUNTY
- 23 AUTHORITY [DEVELOPMENT PLAN REVIEW].
- 24 SECTION 3. Section 232.00285, Local Government Code, is

- 1 amended by adding Subsection (a-1) to read as follows:
- 2 (a-1) Unless specifically authorized by another law of this
- 3 state, the commissioners court of a county or the court's designee
- 4 may not:
- 5 (1) require a person to submit or obtain approval of
- 6 any documentation or other information or fulfill any other
- 7 prerequisites or conditions before the person submits a plat
- 8 application or development plan application to the commissioners
- 9 court or the court's designee;
- 10 (2) delay the starting date for calculating any
- 11 applicable timeframe under this chapter to approve or disapprove
- 12 the plat application or development plan application by not
- 13 considering the date the application was filed as the starting
- 14 date; or
- 15 (3) refuse to accept, acknowledge, process, or act on
- 16 <u>a submitted or received plat application or development plan</u>
- 17 application.
- SECTION 4. Section 212.009(a-1), Local Government Code, as
- 19 added by this Act, applies only to a plan or plat filed on or after
- 20 the effective date of this Act.
- 21 SECTION 5. Section 232.00285(a-1), Local Government Code,
- 22 as added by this Act, applies only to a plat application or
- 23 development plan application submitted on or after the effective
- 24 date of this Act.
- 25 SECTION 6. This Act takes effect on the 91st day after the
- 26 last day of the legislative session.
