## A BILL TO BE ENTITLED

- 2 relating to election integrity and security, including by
- 3 preventing fraud in the conduct of elections in this state;
- 4 increasing criminal penalties; creating criminal offenses;
- 5 providing civil penalties.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 ARTICLE 1. REGISTRATION OF VOTERS
- 8 SECTION 1.01. Section 13.002, Election Code, is amended by
- 9 adding Subsection (c-1) to read as follows:
- 10 (c-1) The information required under Subsection (c) must be
- 11 supplied by the person desiring to register to vote.
- 12 SECTION 1.02. Section 15.021, Election Code, is amended by
- 13 amending Subsections (b) and (d) and adding Subsections (d-1) and
- 14 (d-2) to read as follows:
- (b) Except as provided by Subsection (d), the [The] voter
- 16 shall use the registration certificate or a registration
- 17 application form as the notice, indicating the correct information
- 18 in the appropriate space on the certificate or application form
- 19 unless the voter does not have possession of the certificate or an
- 20 application form at the time of giving the notice.
- 21 (d) A voter [who continues to reside in the county in which
- 22 the voter is registered] may correct information under this section
- 23 by digital transmission of the information under a program
- 24 administered by the secretary of state and the Department of

- 1 Information Resources.
- 2 (d-1) If the notice indicates that a voter no longer resides
- 3 <u>in the county in which the voter is registered</u>, the registrar shall
- 4 forward the notice and the voter's original application for
- 5 registration to the registrar of the county in which the voter
- 6 resides. The registrars shall coordinate to ensure that the
- 7 voter's existing registration is canceled immediately after the
- 8 voter is registered in the county in which the voter resides in
- 9 accordance with Subsection (d-2).
- 10 <u>(d-2)</u> A registrar who receives a voter's notice and
- 11 application from another registrar under Subsection (d-1) shall
- 12 treat it as an original application for registration under Section
- 13 13.002, and shall register the voter if the voter resides in the
- 14 county and is otherwise eligible under Section 13.001.
- 15 SECTION 1.03. Section 15.028, Election Code, is amended to
- 16 read as follows:
- 17 Sec. 15.028. NOTICE OF UNLAWFUL VOTING OR REGISTRATION [TO
- 18 PROSECUTOR]. [(a)] If the registrar determines that a person who
- 19 is not <u>eligible to vote registered to vote or</u> [<del>a registered voter</del>]
- 20 voted in an election, the registrar shall execute and deliver to the
- 21 attorney general, the secretary of state, and the county or
- 22 district attorney having jurisdiction in the territory covered by
- 23 the election an affidavit stating the relevant facts.
- 24 [(b) If the election covers territory in more than one
- 25 county, the registrar shall also deliver an affidavit to the
- 26 attorney general.
- 27 SECTION 1.04. Section 16.0332, Election Code, is amended by

- 1 amending Subsection (a) and adding Subsections (a-1), (d), and (e)
- 2 to read as follows:
- 3 (a) After the registrar receives <u>notification</u> [a list]
- 4 under <u>Subsection (a-1) of this section</u>, Section 18.068 of this
- 5 code, or Section 62.113, Government Code, of persons excused or
- 6 disqualified from jury service because of citizenship status or
- 7 notification of persons who indicate a lack of citizenship status
- 8 in connection with a motor vehicle or Department of Public Safety
- 9 record, the registrar shall deliver to each registered voter whose
- 10 name appears on the list a written notice requiring the voter to
- 11 submit to the registrar proof of United States citizenship in the
- 12 form of a certified copy of the voter's birth certificate, United
- 13 States passport, or certificate of naturalization or any other form
- 14 prescribed by the secretary of state. The notice shall be delivered
- 15 by forwardable mail to the mailing address on the voter's
- 16 registration application and to any new address of the voter known
- 17 to the registrar.
- 18 (a-1) The secretary of state shall enter into an agreement
- 19 with the Department of Public Safety under which information in the
- 20 existing statewide computerized voter registration list is
- 21 compared against information in the database of the Department of
- 22 Public Safety on a monthly basis to verify the accuracy of
- 23 citizenship status information previously provided on voter
- 24 registration applications.
- 25 <u>(d) The secretary of state shall prescribe rules for the</u>
- 26 administration of this section.
- (e) Not later than December 31 of each year, the secretary

- 1 of state shall provide a report to the legislature of the number of
- 2 voter registrations canceled under this section during the calendar
- 3 year.
- 4 SECTION 1.05. Section 18.068, Election Code, is amended by
- 5 amending Subsection (a) and adding Subsection (a-1) to read as
- 6 follows:
- 7 (a) The secretary of state shall quarterly compare the
- 8 information received under Section 16.001 of this code and Sections
- 9 [Section] 62.113 and 62.114, Government Code, to the statewide
- 10 computerized voter registration list. If the secretary determines
- 11 that a voter on the registration list is deceased or has been
- 12 excused or disqualified from jury service because the voter is not a
- 13 citizen or a resident of the county in which the voter is registered
- 14 to vote, the secretary shall send notice of the determination to:
- 15 <u>(1)</u> the voter registrar of the counties considered
- 16 appropriate by the secretary; and
- 17 (2) the attorney general, who shall quarterly review
- 18 the information to investigate whether a person has committed an
- 19 offense under Section 13.007 or other law.
- 20 <u>(a-1)</u> The secretary of state is not required to send notice
- 21 under Subsection (a) for a voter who is subject to an exemption from
- 22 jury service under Section 62.106, Government Code.
- 23 SECTION 1.06. Section 31.006, Election Code, is amended to
- 24 read as follows:
- Sec. 31.006. REFERRAL [OF COMPLAINT] TO ATTORNEY GENERAL.
- 26 (a) If, after receiving or discovering information indicating that
- 27 [a complaint alleging] criminal conduct in connection with an

- 1 election has occurred, the secretary of state determines that there
- 2 is reasonable cause to suspect that [the alleged] criminal conduct
- 3 occurred, the secretary shall promptly refer the <u>information</u>
- 4 [complaint] to the attorney general. The secretary shall deliver to
- 5 the attorney general all pertinent documents and information in the
- 6 secretary's possession.
- 7 (b) The documents <u>and information</u> submitted under
- 8 Subsection (a) are not considered public information until:
- 9 (1) the secretary of state makes a determination that
- 10 the <u>information</u> [complaint] received does not warrant an
- 11 investigation; or
- 12 (2) if referred to the attorney general, the attorney
- 13 general has completed the investigation or has made a determination
- 14 that the <u>information</u> [complaint] referred does not warrant an
- 15 investigation.
- SECTION 1.07. Section 62.113(b), Government Code, is
- 17 amended to read as follows:
- 18 (b) On the third business day of each month, the clerk shall
- 19 send a copy of the list of persons excused or disqualified because
- 20 of citizenship in the previous month to:
- 21 (1) the voter registrar of the county;
- 22 (2) the secretary of state; and
- 23 (3) the <u>attorney general and the</u> county or district
- 24 attorney[, as applicable,] for an investigation of whether the
- 25 person committed an offense under Section 13.007, Election Code, or
- 26 other law.
- SECTION 1.08. Sections 62.114(b) and (c), Government Code,

- 1 are amended to read as follows:
- 2 (b) On the third business day of each month, the clerk shall
- 3 send [to the voter registrar of the county] a copy of the list of
- 4 persons excused or disqualified in the previous month because the
- 5 persons do not reside in the county to:
- 6 (1) the voter registrar of the county;
- 7 (2) the secretary of state; and
- 8 (3) the attorney general and the county or district
- 9 attorney for an investigation of whether the person committed an
- 10 offense under Section 13.007, Election Code, or other law.
- 11 (c) A list compiled under this section may not be used for a
- 12 purpose other than a purpose described by Subsection (b) or Section
- 13 15.081 or 18.068, Election Code.
- 14 ARTICLE 2. CONDUCT AND SECURITY OF ELECTIONS
- SECTION 2.01. Section 43.031(b), Election Code, is amended
- 16 to read as follows:
- 17 (b) Each polling place shall be located inside a building.
- 18 A polling place may not be located in a tent or similar temporary
- 19 <u>moveable structure or in a facility primarily designed f</u>or motor
- 20 vehicles. No voter may cast a vote from inside a motor vehicle
- 21 unless the voter meets the requirements of Section 64.009.
- SECTION 2.02. Section 64.007(c), Election Code, is amended
- 23 to read as follows:
- (c) An election officer shall maintain a register of spoiled
- 25 ballots at the polling place, including spoiled ballots from a
- 26 direct recording electronic voting unit. An election officer shall
- 27 enter on the register the name of each voter who returns a spoiled

- 1 ballot and the spoiled ballot's number. The secretary of state
- 2 shall create and promulgate a form to be used for this purpose.
- 3 SECTION 2.03. Subchapter A, Chapter 65, Election Code, is
- 4 amended by adding Section 65.017 to read as follows:
- 5 Sec. 65.017. VOTE TABULATING EQUIPMENT. Beginning January
- 6 1, 2024, equipment to tabulate votes may not be used if any wireless
- 7 connectivity capability of the equipment has not been disabled or
- 8 removed.
- 9 SECTION 2.04. Subchapter A, Chapter 66, Election Code, is
- 10 amended by adding Section 66.004 to read as follows:
- Sec. 66.004. CLOSING POLLING PLACE. The secretary of state
- 12 shall adopt rules and create a checklist or similar guidelines to
- 13 <u>assist the presiding judge of a polling place in processing forms</u>
- 14 and conducting procedures required by this code at the closing of
- 15 the polling place.
- SECTION 2.05. Section 66.052, Election Code, is amended to
- 17 read as follows:
- 18 Sec. 66.052. DELIVERY BY ELECTION CLERK; CHAIN OF CUSTODY.
- 19 (a) A delivery of election records or supplies that is to be
- 20 performed by the presiding judge may be performed by an election
- 21 clerk designated by the presiding judge.
- (b) If the presiding judge of a polling place designates a
- 23 clerk to deliver election supplies, the presiding judge shall
- 24 attest to the designation, and the clerk shall attest to the clerk's
- 25 <u>acceptance of the responsibility.</u> The secretary of state shall
- 26 create and promulgate a form to facilitate compliance with this
- 27 section.

1 SECTION 2.06. Section 85.005, Election Code, is amended to

2 read as follows:

- Sec. 85.005. REGULAR DAYS AND HOURS FOR VOTING. (a) Except 3 as provided by Subsection (c), in an election in which a county 4 5 clerk [or city secretary] is the early voting clerk under Section 83.002 [or 83.005], early voting by personal appearance at the main 6 early voting polling place shall be conducted on each weekday of 7  $[{\color{blue}{\sf the\ weekdays\ of}}]$  the early voting period  ${\color{blue}{\sf that\ is\ not\ a\ legal\ state}}$ 8 holiday and for a period of at least nine hours, except that voting 9 may not be conducted earlier than 6 a.m. or later than 9 p.m. 10 [during the hours that the county clerk's or city secretary's main 11 12 business office is regularly open for business.
- In an election to which Subsection (a) does not apply, 13 14 early voting by personal appearance at the main early voting 15 polling place shall be conducted at least nine [eight] hours each weekday of the early voting period that is not a legal state holiday 16 17 unless the territory covered by the election has fewer than 1,000 registered voters. In that case, the voting shall be conducted at 18 19 least four [three] hours each day. The authority ordering the election, or the county clerk if that person is the early voting 20 clerk, shall determine which hours the voting is to be conducted. 21
- (c) In a county with a population of 30,000 [100,000] or more, the voting in a primary election or the general election for state and county officers shall be conducted at the main early voting polling place for at least 12 hours on each weekday of the last week of the early voting period, and the voting in a special election ordered by the governor shall be conducted at the main

- 1 early voting polling place for at least 12 hours on each of the last
- 2 two days of the early voting period. <u>Voting under this subsection</u>
- 3 may not be conducted earlier than 6 a.m. or later than 9 p.m. Voting
- 4 shall be conducted in accordance with this subsection in those
- 5 elections in a county with a population under  $30,000 \ [\frac{100,000}{}]$  on
- 6 receipt by the early voting clerk of a written request for the
- 7 extended hours submitted by at least 15 registered voters of the
- 8 county. The request must be submitted in time to enable compliance
- 9 with Section 85.067.
- 10 (d) A voter who has not voted before the scheduled time for
- 11 closing a polling place is entitled to vote after that time if the
- 12 voter is in line at the polling place by closing time. The secretary
- 13 of state shall promulgate any materials and provide any training to
- 14 presiding judges necessary to properly process voters under this
- 15 <u>subsection</u> [In an election ordered by a city, early voting by
- 16 personal appearance at the main early voting polling place shall be
- 17 conducted for at least 12 hours:
- [(1) on one weekday, if the early voting period
- 19 consists of less than six weekdays; or
- 20 [(2) on two weekdays, if the early voting period
- 21 consists of six or more weekdays].
- SECTION 2.07. Sections 85.006(b) and (e), Election Code,
- 23 are amended to read as follows:
- 24 (b) In an election in which a county clerk [<del>or city</del>
- 25 secretary is the early voting clerk under Section 83.002 [or
- 26 83.005], only the early voting clerk may order voting on a Saturday
- 27 or Sunday. The clerk must do so by written order.

- 1 (e) In a primary election or the general election for state and county officers in a county with a population of 30,000 2 3 [100,000] or more, the early voting clerk shall order voting by personal appearance [voting] at the main early voting polling place 4 5 to be conducted on the last Saturday of the early voting period for at least 12 hours, except that voting may not be conducted earlier 6 than 6 a.m. or later than 9 p.m., [on the last Saturday] and on the 7 <u>last Sunday of the early voting period</u> for at least <u>six</u> [<u>five</u>] 8 hours, except that voting may not be conducted earlier than 6 a.m. 9 or later than 9 p.m [on the last Sunday of the early voting period]. 10 The early voting clerk shall order voting to be conducted at those 11 12 times in those elections in a county with a population under 30,000 [100,000] on receipt of a written request for those hours submitted 13 by at least 15 registered voters of the county. The request must be 14 15 submitted in time to enable compliance with Section 85.007. This subsection supersedes any provision of this subchapter to the 16 17 extent of any conflict.
- 18 SECTION 2.08. Section 85.010(a-1), Election Code, is 19 amended to read as follows:
- 20 (a-1) In this section, "eligible county polling place"
  21 means an early voting polling place[, other than a polling place
  22 established under Section 85.062(e), established by a county.
- 23 SECTION 2.09. Section 85.061(a), Election Code, is amended 24 to read as follows:
- 25 (a) In a countywide election in which the county clerk is 26 the early voting clerk under Section 83.002, an early voting 27 polling place shall be located inside [at] each branch office that

- 1 is regularly maintained for conducting general clerical functions
- 2 of the county clerk, except as provided by Subsection (b). If a
- 3 suitable room is unavailable inside the branch office, the polling
- 4 place may be located in another room inside the same building as the
- 5 branch office. The polling place may not be located in a tent or
- 6 similar temporary movable structure or a parking garage, parking
- 7 lot, or similar facility designed primarily for motor vehicles.
- 8 SECTION 2.10. Section 85.062, Election Code, is amended by
- 9 amending Subsection (b) and adding Subsection (f-1) to read as
- 10 follows:
- 11 (b) A polling place established under this section may be
- 12 located, subject to Subsection (d), at any place in the territory
- 13 served by the early voting clerk and may be located inside [in] any
- 14 building [stationary structure] as directed by the authority
- 15 establishing the branch office. The polling place may <u>not</u> be
- 16 located in a tent or similar temporary movable structure or a
- 17 parking garage, parking lot, or similar facility designed primarily
- 18 for motor vehicles in the general election for state and county
- 19 officers, general primary election, or runoff primary election.
- 20 Ropes or other suitable objects may be used at the polling place to
- 21 ensure compliance with Section 62.004. Persons who are not
- 22 expressly permitted by law to be in a polling place shall be
- 23 excluded from the polling place to the extent practicable.
- 24 (f-1) Notwithstanding any other provision of this section
- 25 concerning the location of temporary branch polling places, in an
- 26 <u>election</u> in which countywide polling places are used, the
- 27 commissioners court of a county shall employ the same methodology

- 1 it uses to determine the location of countywide polling places to
- 2 determine the location of temporary branch polling places.
- 3 SECTION 2.11. Section 124.002, Election Code, is amended by
- 4 adding Subsection (c) to read as follows:
- 5 (c) Voting system ballots may not be arranged in a manner
- 6 that allows a political party's candidates to be selected in one
- 7 motion or gesture.
- 8 SECTION 2.12. Section 127.1232, Election Code, is amended
- 9 to read as follows:
- Sec. 127.1232. SECURITY OF VOTED BALLOTS. (a) The general
- 11 custodian of election records shall post a licensed peace officer
- 12 [guard] to ensure the security of ballot boxes containing voted
- 13 ballots throughout the period of tabulation at the central counting
- 14 station.
- 15 (b) The general custodian of election records in a county
- 16 with a population of less than 100,000 may, and the general
- 17 custodian of election records in a county with a population of
- 18 100,000 or more shall, implement a video surveillance system that
- 19 retains a record of all areas containing voted ballots:
- 20 (1) from the time the voted ballots are delivered to
- 21 the central counting station until the canvass of precinct election
- 22 returns; and
- 23 (2) from the time the voted ballots are delivered to
- 24 the signature verification committee or early voting ballot board
- 25 until the canvass of precinct election returns.
- 26 (c) A video from a system implemented under Subsection (b)
- 27 may be made available to the public by a livestream in a county with

- 1 a population of less than 100,000, and shall be made available to
- 2 the public by a livestream in a county with a population of 100,000
- 3 or more.
- 4 (d) The video recorded is an election record under Section
- 5 1.012 and shall be retained by the general custodian of election
- 6 records until the end of the calendar year in which an election is
- 7 held or until an election contest filed in the county has been
- 8 resolved, whichever is later.
- 9 ARTICLE 3. ELECTION OFFICERS AND OBSERVERS
- SECTION 3.01. Section 33.051, Election Code, is amended by
- 11 adding Subsections (g) and (h) to read as follows:
- 12 (g) An election officer commits an offense if the officer
- 13 intentionally or knowingly refuses to accept a watcher for service
- 14 when acceptance of the watcher is required by this section. An
- offense under this subsection is a Class B misdemeanor.
- 16 (h) Before accepting a watcher, the officer presented with a
- 17 watcher's certificate of appointment shall require the watcher to
- 18 take the following oath, administered by the officer: "I swear (or
- 19 affirm) that I will not disrupt the voting process or harass voters
- 20 in the discharge of my duties."
- SECTION 3.02. Section 33.056, Election Code, is amended by
- 22 amending Subsection (a) and adding Subsections (e) and (f) to read
- 23 as follows:
- 24 (a) Except as provided by Section 33.057, a watcher is
- 25 entitled to observe any activity conducted at the location at which
- 26 the watcher is serving. A watcher is entitled to sit or stand
- 27 [conveniently] near enough to see and hear the election officers

- 1 conducting the observed activity, except as otherwise prohibited by
- 2 this chapter.
- 3 (e) Except as provided by Section 33.057(b), a watcher may
- 4 not be denied free movement where election activity is occurring
- 5 within the location at which the watcher is serving.
- 6 (f) In this code, a watcher who is entitled to "observe" an
- 7 election activity is entitled to sit or stand near enough to see and
- 8 hear the activity.
- 9 SECTION 3.03. Subchapter C, Chapter 33, Election Code, is
- 10 amended by adding Section 33.0605 to read as follows:
- 11 Sec. 33.0605. OBSERVING DATA STORAGE SEALING AND TRANSFER.
- 12 (a) A watcher appointed to serve at a polling place in an election
- 13 who is available at the time of the action may observe all election
- 14 activities relating to closing the polling place, including the
- 15 <u>sealing and transfer of a memory card, flash drive, hard drive, data</u>
- 16 storage device, or other medium now existing or later developed
- 17 used by the voting system equipment.
- 18 (b) Notwithstanding any other provision of this code, a
- 19 watcher duly accepted for service at a polling location is entitled
- 20 to follow the transfer of election materials from the polling place
- 21 at which the watcher was accepted to a regional tabulating center,
- 22 the central counting station, or any other location designated to
- 23 process election materials. The authority responsible for
- 24 administering a regional tabulating center or another location
- 25 where election materials are processed must accept duly appointed
- 26 watchers for service in the same manner a watcher is accepted for
- 27 service under Section 33.051 and must accept the same number of

- 1 watchers that may serve under Section 33.007(a).
- 2 SECTION 3.04. Section 33.061(a), Election Code, is amended
- 3 to read as follows:
- 4 (a) A person commits an offense if the person serves in an
- 5 official capacity at a location at which the presence of watchers is
- 6 authorized and knowingly prevents a watcher from observing an
- 7 activity or procedure the person knows the watcher is entitled to
- 8 observe, including by taking any action to obstruct the view of a
- 9 watcher or distance the watcher from the activity or procedure to be
- 10 observed in a manner that would make observation not reasonably
- 11 <u>effective</u>.
- 12 SECTION 3.05. Subchapter C, Chapter 33, Election Code, is
- 13 amended by adding Section 33.063 to read as follows:
- Sec. 33.063. RELIEF. (a) A watcher, or the appointing
- 15 <u>authority</u> for a watcher, who believes that the watcher was
- 16 unlawfully prevented or obstructed from the performance of the
- 17 watcher's duties may seek:
- 18 (1) injunctive relief under Section 273.081,
- 19 including issuance of temporary orders;
- 20 (2) a writ of mandamus under Section 161.009 or
- 21 <u>273.061</u>; and
- 22 (3) any other remedy available under law.
- 23 (b) The relief provided by this section is available to a
- 24 state inspector appointed under Chapter 34 or any other election
- 25 inspector authorized by law.
- SECTION 3.06. Section 86.006, Election Code, is amended by
- 27 amending Subsection (a) and adding Subsection (a-2) to read as

- 2 (a) A marked ballot voted under this chapter must be
- 3 returned to the early voting clerk in the official carrier
- 4 envelope. The carrier envelope may be delivered in another
- 5 envelope and must be transported and delivered only by:
- 6 (1) mail;
- 7 (2) common or contract carrier; or
- 8 (3) subject to <u>Subsections</u> [Subsection] (a-1) and
- 9 (a-2), in-person delivery by the voter who voted the ballot.
- 10 <u>(a-2)</u> An in-person delivery of a marked ballot voted under
- 11 this chapter must be received by an election official at the time of
- 12 delivery. The receiving official shall record the voter's name,
- 13 signature, and type of identification provided under Section
- 14 63.0101 on a roster prescribed by the secretary of state. The

- 17 SECTION 3.07. Chapter 121, Election Code, is amended by

- 19 Sec. 121.004. COMMUNICATIONS WITH VOTING SYSTEMS VENDOR
- 20 PUBLIC INFORMATION. (a) Except as provided by Subsection (b) and
- 21 <u>notwithstanding any other law, including Chapter 552, Government</u>
- 22 Code, a written letter, e-mail, or other communication, including a
- 23 communication made confidential by other law, between a public
- 24 official and a voting systems vendor:
- 25 (1) is not confidential;
- 26 (2) is public information for purposes of Chapter 552,
- 27 Government Code; and

- 1 (3) is not subject to an exception to disclosure
- 2 provided by Chapter 552, Government Code.
- 3 (b) Subsection (a) does not apply to a written letter,
- 4 e-mail, or other communication related to the bidding process.
- 5 SECTION 3.08. Subchapter A, Chapter 127, Election Code, is
- 6 amended by adding Section 127.009 to read as follows:
- 7 Sec. 127.009. ELECTRONIC DEVICES IN CENTRAL COUNTING
- 8 STATION. (a) A counting station manager and the presiding judge of
- 9 the counting station shall develop a protocol under which any
- 10 electronic device inside a central counting station that is
- 11 necessary to count votes is equipped with software that tracks all
- 12 input and activity on the electronic device.
- 13 (b) The counting station manager and the presiding judge of
- 14 the counting station shall ensure that the input and activity
- 15 tracked by the software is printed and delivered to the secretary of
- 16 state not later than the fifth day after vote counting is complete.
- 17 (c) This section applies only to a central counting station
- 18 located in a county with a population of 250,000 or more.
- 19 SECTION 3.09. Section 127.1301, Election Code, is amended
- 20 to read as follows:
- 21 Sec. 127.1301. [TALLYING, TABULATING, AND REPORTING]
- 22 CENTRALLY COUNTED OPTICAL SCAN BALLOTS [BALLOT UNDERVOTES AND
