Section 11.002(a), Election Code, is amended to read as follows: 6 7 (a) In this code, "qualified voter" means a person who: is 18 years of age or older; (1) 8 (2) is a United States citizen; 9 has not been determined by a final judgment of a 10 (3) court exercising probate jurisdiction to be: 11 12 (A) totally mentally incapacitated; or 13 (B) partially mentally incapacitated without the 14 right to vote; has not been finally convicted of a felony or, if (4) 15 16 so convicted, is not currently incarcerated for that offense [has: 17 [(A) fully discharged the person's sentence, 18 including any term of incarceration, parole, or supervision, or completed a period of probation ordered by any court; or 19 20 [(B) been pardoned or otherwise released from the 21 resulting disability to vote]; (5) is a resident of this state; and 22 23 (6) is a registered voter. SECTION 2. Section 13.001(a), Election Code, is amended to 24

No. 51 read as follows: 1 2 (a) To be eligible for registration as a voter in this 3 state, a person must: 4 (1) be 18 years of age or older; 5 (2) be a United States citizen; 6 (3) not have been determined by a final judgment of a 7 court exercising probate jurisdiction to be: 8 (A) totally mentally incapacitated; or 9 (B) partially mentally incapacitated without the 10 right to vote; not have been finally convicted of a felony or, if 11 (4) 12 so convicted, must not currently be incarcerated for that offense 13 [<del>have:</del> 14 [(A) fully discharged the person's sentence, 15 including any term of incarceration, parole, or supervision, or completed a period of probation ordered by any court; or 16 17 [(B) been pardoned or otherwise released from the resulting disability to vote]; and 18 be a resident of the county in which application 19 (5) for registration is made. 20 SECTION 3. This Act takes effect immediately if it receives 21 a vote of two-thirds of all the members elected to each house, as 2.2 provided by Section 39, Article III, Texas Constitution. If this 23 24 Act does not receive the vote necessary for immediate effect, this 25 Act takes effect on the 91st day after the last day of the 26 legislative session.
