A BILL TO BE ENTITLED

1	AN ACT
2	
3	Relating to the Barbara Jordan Fair Elections Act.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	ARTICLE 1. GENERAL PROVISIONS
6	SECTION 1.01. SHORT TITLE. This Act may be cited as the
7	Barbara Jordan Fair Elections Act.
8	SECTION 1.02. PURPOSE. The purpose of this Act is to
9	exercise the legislature's constitutional authority under Section
10	2, Article VI, Texas Constitution, to ensure that "The privilege of
11	free suffrage shall be protected by laws regulating elections and
12	prohibiting under adequate penalties all undue influence in
13	elections from power, bribery, tumult, or other improper practice."
14	SECTION 1.03. FINDINGS. The legislature finds that:
15	(1) full, free, and fair elections are the
16	underpinnings of a stable constitutional democracy;
17	(2) the privilege of free suffrage shall be protected
18	by laws regulating elections;
19	(3) maximizing the potential for safe, secure, and
20	accessible elections and enhancing the opportunities to vote
21	strengthen our constitutional democracy and provide for wide-scale
22	confidence in elections;
23	(4) additionally, preventing a valid vote from being
24	cast or counted violates the basic constitutional rights guaranteed

1 to each citizen by the United States Constitution and the law of the 2 land; and

3 (5) providing for voter access and increasing the 4 stability of a constitutional democracy ensures public confidence 5 in the legitimacy of public officers chosen by election.

6 SECTION 1.04. Chapter 1, Election Code, is amended by 7 adding Section 1.0015 to read as follows:

8 <u>Sec. 1.0015. LEGISLATIVE INTENT. It is the intent of the</u> 9 <u>legislature that the application of this code and the conduct of</u> 10 <u>elections shall be uniform and consistent throughout this state to</u> 11 <u>promote voter access and ensure that all lawfully cast votes are</u> 12 <u>counted.</u>

13 SECTION 1.05. Section 1.003, Election Code, is amended by 14 adding Subsection (a-1) to read as follows:

15 <u>(a-1) A public official shall construe the provisions of</u> 16 <u>this code broadly to effect the intent of the legislature under</u> 17 <u>Section 1.0015.</u>

SECTION 2.01. Subchapter A, Chapter 13, Election Code, is amended by adding Section 13.009 to read as follows:

ARTICLE 2. VOTER REGISTRATION

Sec. 13.009. ELECTRONIC VOTER REGISTRATION. (a) The secretary of state shall implement a program to allow a person to complete a voter registration application over the Internet from the official website of this state. The websites of the secretary of state and the Department of Public Safety must also provide a link to the location of the application on the official website of this state.

1	(b) An applicant for electronic voter registration who has a
2	driver's license or personal identification card issued in this
3	state, regardless of whether the license or card is unexpired,
4	must:
5	(1) attest to the truth of the information provided on
6	the application by affirmatively accepting the information as true;
7	and
8	(2) affirmatively consent to the use of the signature
9	on the applicant's driver's license or personal identification card
10	for voter registration purposes.
11	(c) An applicant for electronic voter registration who does
12	not have a driver's license or personal identification card issued
13	in this state must:
14	(1) attest to the truth of the information provided on
15	the application by affirmatively accepting the information as true;
16	and
17	(2) print a registration application from the website
18	the applicant is using to register, sign the application, and mail
19	it to the registrar.
20	(d) For each application submitted under Subsection (b),
21	the program must require that a digital copy of the applicant's
22	signature be obtained from the Department of Public Safety.
23	(e) For each application submitted under Subsection (c),
24	the program must provide the applicant with:
25	(1) a registration application that the applicant can
26	print from the registration website, sign, and mail to the
27	registrar as required under Subsection (c)(2); and

1	(2) information about how the applicant can obtain a
2	driver's license or personal identification card from the
3	Department of Public Safety.
4	(f) An application submitted under this section is
5	considered for all purposes an application submitted by mail under
6	this title.
7	(g) The secretary of state shall adopt rules as necessary to
8	implement this section, including rules to provide for additional
9	security measures necessary to ensure the accuracy and integrity of
10	applications submitted electronically.
11	(h) The rules adopted under Subsection (g) must require
12	that:
13	(1) the Internet website through which a person may
14	complete a voter registration application include a description of
15	the offense described by Section 13.007 in a conspicuous location
16	on the website near the place where the person begins or submits the
17	application; and
18	(2) the state electronic Internet portal project be
19	used to authenticate the identity of a person who submits an
20	application electronically under this section.
21	SECTION 2.02. Sections 84.001(b) and (d), Election Code,
22	are amended to read as follows:
23	(b) An application must be in writing and signed by the
24	applicant. Except as provided by Section 84.0091, an [An]
25	electronic signature is not permitted.
26	(d) An application must be submitted [by mail] to the early
27	voting clerk for the election who serves the election precinct of

the applicant's residence. 1 SECTION 2.03. Subchapter A, Chapter 13, Election Code, is 2 amended by adding Section 13.009 to read as follows: 3 4 Sec. 13.009. VOTER REGISTRATION THROUGH DEPARTMENT OF PUBLIC SAFETY. (a) The voter registrar of each county shall 5 automatically register any county resident who is eligible to vote 6 7 as provided by Section 13.001 and: 8 (1) is issued a Texas driver's license or a personal 9 identification card by the Department of Public Safety; or (2) makes a change to a Texas driver's license or 10 11 personal identification card issued by the Department of Public 12 Safety. (b) A driver's license or personal identification card 13 transaction with an indication provided by Section 20.062(b) or 14 15 20.063(c) that the transaction is not for voter registration 16 purposes is not subject to this section. 17 SECTION 2.04. Section 20.061, Election Code, is amended to read as follows: 18 Sec. 20.061. APPLICABILITY OF OTHER PROVISIONS. The other 19 20 provisions of this chapter apply to the Department of Public Safety except provisions that conflict with this subchapter or Section 21 22 13.009. SECTION 2.05. Section 20.062(b), Election Code, is amended 23 24 to read as follows: 25 (b) The department shall prescribe and use a change of address form and procedure that combines department and voter 26 27 registration functions. The form must allow a licensee or

cardholder to indicate <u>that</u> [whether] the change of address is <u>not</u>
 [also to be used] for voter registration purposes.

3 SECTION 2.06. Section 20.063, Election Code, is amended to 4 read as follows:

5 Sec. 20.063. REGISTRATION PROCEDURES. (a) The Department of Public Safety shall consider an application made in person, by 6 7 mail, or online at the department's Internet website [provide to each person who applies in person at the department's offices] for 8 9 an original or renewal of a driver's license, a personal identification card, or a duplicate or corrected license or card by 10 11 a person who is eligible to vote as provided by Section 13.001 an application for [opportunity to complete a] voter registration. 12 13 The date of application is considered to be the date of submission to the voter registrar for the purpose of determining the effective 14 15 date of registration [application form].

(b) <u>The Department of Public Safety shall consider a change</u> of address that relates to [When the department processes] a license or card <u>and that is submitted to</u> [for renewal by mail,] the department [shall deliver to the applicant by mail a voter registration application form.

[(c) A change of address that relates to a license or card and that is submitted to the department] in person, [or] by mail, or online at the department's Internet website [serves] as a change in [of address for] voter registration [unless the licensee or cardholder indicates that the change is not for voter registration purposes]. The date of submission of a change of address to a department employee is considered to be the date of submission to

the voter registrar for the purpose of determining the effective
 date of registration [only].

(c) The registration of an eligible [(d) If a completed] 3 voter as required by Subsections (a) and (b) is automatic unless the 4 person indicates that the transaction is not for voter 5 registration purposes [application submitted to a department 6 7 employee does not include the applicant's correct driver's license number or personal identification card number, a department 8 9 employee shall enter the appropriate information on the application. If a completed application does not include the 10 applicant's correct residence address or mailing address, a 11 department employee shall obtain the appropriate information from 12 the applicant and enter the information on the application]. 13

SECTION 2.07. Section 20.065(b), Election Code, is amended to read as follows:

16 (b) Each weekday the department is regularly open for 17 business, the department shall electronically transfer to the secretary of state the name and information designated by the 18 secretary of state for [of each person who completes a] voter 19 registration for each individual who is eligible to vote as 20 provided by Section 13.001 and applies in person, by mail, or online 21 at the department's Internet website for an original or renewal of a 22 driver's license, a personal identification card, or a duplicate or 23 corrected <u>license or card</u> [application submitted to the 24 25 department]. The secretary shall prescribe procedures necessary to 26 implement this subsection.

27

SECTION 2.08. Section 13.001, Election Code, is amended by

S.B. No. 61 amending Subsections (a) and (b) and adding Subsections (d) and (e) 1 2 to read as follows: (a) To be eligible for registration as a voter in this 3 4 state, a person must: 5 (1)except as provided by Subsection (d), be 18 years of age or older; 6 7 (2) be a United States citizen; not have been determined by a final judgment of a 8 (3) court exercising probate jurisdiction to be: 9 10 totally mentally incapacitated; or (A) 11 (B) partially mentally incapacitated without the 12 right to vote; 13 (4) not have been finally convicted of a felony or, if so convicted, must have: 14 15 (A) fully discharged the person's sentence, 16 including any term of incarceration, parole, or supervision, or completed a period of probation ordered by any court; or 17 18 (B) been pardoned or otherwise released from the resulting disability to vote; and 19 be a resident of the county in which application 20 (5) for registration is made. 21 22 Except as provided by Subsection (d), to [To] be (b) eligible to apply for registration, a person must, on the date the 23 24 registration application is submitted to the registrar, be at least 25 17 years and 10 months of age and satisfy the requirements of Subsection (a) except for age. 26 (d) A person who will be 18 years of age or older on the date 27

of the next general election for state and county officers is 1 eligible to register as a voter in this state for the purposes of 2 3 voting in the primary election to determine a political party's nominees for the general election if the person satisfies the 4 requirements of Subsection (a) except for age. The secretary of 5 state shall prescribe procedures necessary to implement this 6 7 subsection. (e) The voter registrar may send a written notice to each 8 9 person who registers to vote under Subsection (d) stating that the person is only eligible to vote in a primary election or runoff 10 11 primary election and that the person is not eligible to vote in any other election until the person is 18 years of age. The notice may 12 13 list the elections in which the person is not eligible to vote. SECTION 2.09. Subchapter A, Chapter 172, Election Code, is 14 15 amended by adding Section 172.005 to read as follows: 16 Sec. 172.005. VOTING BY PERSON UNDER AGE 18. (a) Notwithstanding Section 11.001, a person may vote in a primary 17 election if the person: 18 (1) will be 18 years of age or older on the date of the 19 20 subsequent general election for state and county officers; and 21 (2) satisfies the requirements for being a qualified voter except for age. 22 (b) The secretary of state, after consulting with the state 23 chairman of each political party required to make nominations by 24 primary election, shall prescribe the procedures necessary to 25 26 implement this section. 27 SECTION 2.10 Chapter 521A, Texas Transportation Code is

amended as follows: 1 Sec. 521A.002. ELECTION IDENTIFICATION CERTIFICATE FOR 2 HIGH SCHOOL STUDENTS. (a) The Department shall, at no cost to the 3 student, issue an election identification certificate to any 4 5 student who requests one and: 6 (1) is, on the date of the request, at least 17 years 7 and five months of age; and 8 (2) provides proof of enrollment showing the student 9 is currently enrolled in a Texas public high school, private school, public or private charter school, or accredited homeschool 10 11 program. SECTION 2.11. Chapter 63, Election Code, is amended by 12 13 adding Section 63.010 to read as follows: Sec. 63.010. REGISTRATION AT POLLING PLACE. (a) A person 14 15 who would be eligible to vote in an election under Section 11.001, 16 but for the requirement to be a registered voter, shall be accepted during voting by personal appearance for voting the ballot for the 17 18 precinct of the person's residence as shown by the identification presented if, on the day the person offers to vote, the person: 19 20 (1) submits a voter registration application that complies with Section 13.002 to an election officer at the polling 21 place; and 22 (2) presents as proof of residence a form of photo 23 identification described by Section 63.0101(a) that states the 24 25 person's current address. (b) The election officer shall return the original proof of 26 27 residence to the voter.

1	(c) A person voting under this section shall vote a
2	provisional ballot in the manner provided by Section 63.011 except
3	that the person is not required to submit the affidavit under
4	Section 63.011(a).
5	(d) For each registration corresponding to a ballot cast
6	under this section, the voter registrar shall review the
7	application and determine whether the applicant is eligible for
8	registration as provided by Subchapter C, Chapter 13. A
9	registration approved under this subsection takes effect on the
10	date the vote was cast.
11	ARTICLE 3. VOTE BY MAIL
12	SECTION 3.01. Section 82.005, Election Code, is amended to
13	read as follows:
14	Sec. 82.005. ELIGIBILITY FOR EARLY VOTING [BY PERSONAL
15	APPEARANCE]. Any qualified voter is eligible for early voting by
16	<u>mail or</u> personal appearance.
17	SECTION 3.02. Section 84.007(a), Election Code, is amended
18	to read as follows:
19	(a) Except as provided by Sections 84.008 <u>,</u> [and] 84.009, <u>and</u>
20	$\underline{84.0091}$, an application for a ballot to be voted by mail must be
21	submitted as provided by this section.
22	SECTION 3.03. Subchapter A, Chapter 84, Election Code, is
23	amended by adding Section 84.0091 to read as follows:
24	Sec. 84.0091. SUBMITTING APPLICATION FOR BALLOT VOTED BY
25	MAIL: ELECTRONIC SUBMISSION. The secretary of state shall
26	implement a program to allow a person to complete an application for
27	an early voting ballot by mail over the Internet from the official

1	website of this state. The program must:
2	(1) permit an applicant to electronically sign the
3	application;
4	(2) deliver a completed application to the early
5	voting clerk for the election who serves the election precinct of
6	the applicant's residence; and
7	(3) permit an applicant to check the status of the
8	applicant's application.
9	SECTION 3.04. Subchapter C, Chapter 87, Election Code, is
10	amended by adding Section 87.0411 to read as follows:
11	Sec. 87.0411. OPPORTUNITY TO CORRECT DEFECT: EARLY VOTING
12	BALLOT BOARD. (a) This section applies to an early voting ballot
13	voted by mail:
14	(1) for which the voter did not sign the carrier
15	envelope certificate;
16	(2) for which it cannot immediately be determined
17	whether the signature on the carrier envelope certificate is that
18	of the voter; or
19	(3) that does not contain a statement of residence
20	form if required under Section 86.002(a).
21	(b) Before deciding whether to accept or reject a ballot
22	under Section 87.041, the early voting ballot board shall notify a
23	voter within one business day of the discovery of a defect under
24	Subsection (a) to advise the voter of the defect and provide the
25	voter an opportunity to correct the defect by providing:
26	(1) if the defect involves the voter's signature:
27	(A) the following identification:

1	(i) the identification number from an
2	unexpired driver's license, election identification certificate,
3	or personal identification card issued to the voter by the
4	Department of Public Safety;
5	(ii) the last four digits of the voter's
6	social security number; or
7	(iii) if the voter does not possess any
8	identification described by Subparagraph (i) or (ii), a form of
9	identification described by Section 63.0101; and
10	(B) a signed cure attestation in a form
11	prescribed by the secretary of state stating that the ballot at
12	issue is that of the voter; or
13	(2) if the defect involves a required statement of
14	residence form, a signed and completed statement of residence form.
15	(c) Subsection (b) does not apply if the early voting ballot
16	board determines that it would be impossible to correct the defect
17	before the ninth day after the date of the election.
18	(d) A voter may submit materials listed under Subsection (b)
19	to the early voting clerk by:
20	(1) personal delivery;
21	<u>(2) mail;</u>
22	(3) e-mail; or
23	(4) telephonic facsimile machine, if a machine is
24	available in the clerk's office.
25	(e) The notice under Subsection (b) must:
26	(1) inform the voter that the voter's vote will not be
27	counted unless the voter submits the materials listed under

1	Subsection (b) not later than the ninth day after the date of the
2	election;
3	(2) instruct the voter on the methods of returning the
4	materials listed under Subsection (b);
5	(3) include a copy of the cure attestation or
6	statement of residence in the form prescribed by the secretary of
7	state; and
8	(4) direct the voter to the location of the cure
9	attestation or statement of residence form on the secretary of
10	state's Internet website.
11	(f) The early voting ballot board shall provide notice to
12	the voter under Subsection (b) by mail and any other method
13	reasonably calculated to provide sufficient time for the voter to
14	submit the required materials before the deadline prescribed by
15	this section.
16	(g) The early voting ballot board is not required to provide
17	notice under Subsection (b) if the board makes a determination
18	under Section 87.027(j) that the signature on the carrier envelope
19	certificate and ballot application are those of the voter.
20	(h) If the early voting ballot board does not provide notice
21	to the voter under Subsection (b) and the ballot meets the
22	requirements of Sections 87.041(b)(1), (3), (4), (5), (6), and (7),
23	the board shall accept the ballot in the manner provided by Section
24	87.042.
25	(i) The secretary of state shall:
26	(1) prominently display and maintain on the main page
27	of the secretary's Internet website a link to blank versions of the

5	(j) A statement of residence form or a cure attestation
6	prescribed under this section must include clear instructions for

8	fraud and voting more than once in an election. The cure attestation
9	and statement of residence may not require the voter to have the
10	form notarized or signed by a witness.
11	(k) The signature provided by the voter on a cure
12	attestation or a statement of residence form shall be placed on file
13	with the county clerk or voter registrar to allow its use for future
14	signature comparison as provided by Sections 87.027(i) and
15	<u>87.041(e).</u>
16	ARTICLE 4. POLLING PLACES
17	SECTION 4.01. Subchapter A, Chapter 43, Election Code, is
18	amended by adding Section 43.008 to read as follows:
19	Sec. 43.008. CAMPUS POLLING PLACES. (a) In this section,
20	"institution of higher education" has the meaning assigned by
21	Section 61.003, Education Code.
22	(b) The commissioners court of a county shall designate as a
23	polling place a number of locations on the main campus of an
24	institution of higher education located in the county as follows:
25	(1) if at least 5,000 but fewer than 10,000 students
26	are enrolled at the institution, one location; or
27	(2) if at least 10,000 students are enrolled at the

1 institution, two locations and one additional location for every
2 10,000 students enrolled at the institution over 10,000 students.

3 SECTION 4.02. Section 85.005(c), Election Code, is amended 4 as follows:

5 In a county with a population of 30,000 [100,000] or (c) more, the voting in a primary election or the general election for 6 7 state and county officers shall be conducted at the main early voting polling place for at least 12 hours on each weekday of the 8 9 last week of the early voting period, and the voting in a special election ordered by the governor shall be conducted at the main 10 11 early voting polling place for at least 12 hours on each of the last two days of the early voting period. Voting shall be conducted in 12 accordance with this subsection in those elections in a county with 13 a population under 30,000 [100,000] on receipt by the early voting 14 15 clerk of a written request for the extended hours submitted by at least 15 registered voters of the county. The request must be 16 submitted in time to enable compliance with Section 85.067. 17

18 SECTION 4.03. Section 43.007(i), Election Code, is 19 repealed.

20 SECTION 4.04. Sections 43.007(c) and (d), Election Code, 21 are amended to read as follows:

(c) In conducting the program, the secretary of state shall
 provide for an audit of the <u>voting system equipment</u> [direct
 recording electronic voting units] before and after the election,
 and during the election to the extent such an audit is practicable.

26 (d) The secretary of state shall select to participate in27 the program each county that:

14 (5) is determined by the secretary of state to have the 15 appropriate technological capabilities.

ARTICLE 5. VOTING BY PERSONAL APPEARANCE

SECTION 5.01. Section 85.001(a), Election Code, is amended to read as follows:

(a) The period for early voting by personal appearance
begins on the <u>21st</u> [17th] day before election day and continues
through the fourth day before election day, except as otherwise
provided by this section.

23 SECTION 5.02. Section 13.002(i), Election Code, as 24 effective September 1, 2021, is amended to read as follows:

(i) An applicant who wishes to receive an exemption from the requirements of Section 63.001(b) on the basis of disability must submit:

(1) written documentation: 1 (A) from the United States Social 2 Security Administration evidencing the applicant has been determined to have 3 4 a disability; or 5 from the United States Department of Veterans (B) Affairs evidencing the applicant has a disability rating of at 6 7 least 50 percent; and (2) a statement in a form prescribed by the secretary 8 9 of state that the applicant does not have [a form of] identification required by Section 63.001(b) in a form described by [acceptable 10 under] Section 63.0101. 11 SECTION 5.03. Sections 63.001(b) and (i), Election Code, 12 are amended to read as follows: 13 (b) Except as provided by Subsection (h), on offering to 14 vote, a voter must present to an election officer at the polling 15 16 place: 17 (1) one form of photo identification listed in Section 63.0101(a); [or] 18 (2) one form of identification listed in Section 19 20 63.0101(b)(1), (2), or (3) accompanied by the declaration described by Subsection (i); 21 22 (3) two forms of identification listed under Section 63.0101(b), including one form that contains the voter's current 23 address; or 24 25 (4) two forms of identification listed under Section 63.0101(b)(4) accompanied by the declaration described by 26 27 Subsection (i).

1 If the requirement for identification prescribed by (i) 2 Subsection (b)(1) or (3) is not met, an election officer shall notify the voter that the voter may be accepted for voting if the 3 4 voter meets the requirement for identification prescribed by Subsection (b)(2) or (4) and executes a declaration declaring the 5 voter has a reasonable impediment to meeting the requirement for 6 7 identification prescribed by Subsection (b)(1) or (3). A person is subject to prosecution for perjury under Chapter 37, Penal Code, or 8 9 Section 63.0013 for a false statement or false information on the declaration. The secretary of state shall prescribe the form of the 10 declaration. The form shall include: 11

(1) a notice that a person is subject to prosecution
for perjury under Chapter 37, Penal Code, or Section 63.0013 for a
false statement or false information on the declaration;

(2) a statement that the voter swears or affirms that the information contained in the declaration is true, that the person described in the declaration is the same person appearing at the polling place to sign the declaration, and that the voter faces a reasonable impediment to procuring the identification prescribed by Subsection (b)(1) or (3);

21 (3) a place for the voter to indicate one of the 22 following impediments:

(A) lack of transportation;
(B) lack of birth certificate or other documents
needed to obtain the identification prescribed by Subsection
(b)(1);
(C) work schedule;

(D) lost or stolen identification; 1 2 (E) disability or illness; family responsibilities; and (F) 3 4 (G) the identification prescribed by Subsection (b)(1) or (3) has been applied for but not received; 5 6 (4) a place for the voter to sign and date the 7 declaration; (5) a place for the election judge to sign and date the 8 9 declaration; 10 (6) a place to note the polling place at which the 11 declaration is signed; and a place for the election judge to note which form 12 (7) 13 of identification prescribed by Subsection (b)(2) or (4) the voter 14 presented. 15 SECTION 5.04. Sections 63.0101(a) and (b), Election Code, 16 are amended to read as follows: 17 (a) The following documentation is an acceptable form of photo identification under this chapter: 18 (1) a driver's license, election identification 19 certificate, or personal identification card issued to the voter 20 [person] by the Department of Public Safety that has not expired or 21 that expired no earlier than four years before the date of 22 presentation; 23 a United States military identification card that 24 (2) 25 contains the voter's [person's] photograph that has not expired or that expired no earlier than four years before the date of 26 27 presentation;
