- 3 security and giving direction regarding those appropriations.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. OFFICE OF COURT ADMINISTRATION, TEXAS JUDICIAL
- 6 COUNCIL. (a) The amount of \$32,486,125 is appropriated from the
- 7 general revenue fund to the Office of Court Administration, Texas
- 8 Judicial Council for the purpose of providing funding for indigent
- 9 legal representation, foreign language interpreters for courts,
- 10 increased staff functions, equipment purchases, and program
- 11 administration costs during the two-year period beginning on the
- 12 effective date of this Act.
- 13 (b) During the two-year period beginning on the effective
- 14 date of this Act, in addition to the number of full-time equivalent
- 15 (FTE) employees other law authorizes the office to employ during
- 16 that period, the Office of Court Administration, Texas Judicial
- 17 Council may employ out of money appropriated by Subsection (a) of
- 18 this section six full-time equivalent (FTE) employees.
- 19 (c) Out of money appropriated by Subsection (a) of this
- 20 section, the Office of Court Administration, Texas Judicial Council
- 21 shall transfer \$905,200 to the Comptroller's Department, Judiciary
- 22 Section for the purpose of providing funding for visiting judges.
- SECTION 2. MILITARY DEPARTMENT. The amount of \$301,007,231
- 24 is appropriated from the general revenue fund to the Military

- 1 Department for the purpose of providing funding for additional
- 2 personnel to support border security operations during the two-year
- 3 period beginning on the effective date of this Act.
- 4 SECTION 3. DEPARTMENT OF PUBLIC SAFETY. (a) The amount of
- 5 \$133,506,725 is appropriated from the general revenue fund to the
- 6 Department of Public Safety for the purpose of providing funding
- 7 for 52 weeks of Operation Lone Star surge costs incurred during the
- 8 two-year period beginning on the effective date of this Act.
- 9 (b) The amount of \$3,411,000 is appropriated from the
- 10 general revenue fund to the Department of Public Safety for the
- 11 purpose of providing funding to purchase tactical marine unit
- 12 vessels during the two-year period beginning on the effective date
- 13 of this Act.
- 14 (c) The amount of \$17,872,349 is appropriated from the
- 15 general revenue fund to the Department of Public Safety for the
- 16 purpose of providing funding for additional full-time equivalent
- 17 (FTE) employees during the two-year period beginning on the
- 18 effective date of this Act.
- 19 (d) During the two-year period beginning on the effective
- 20 date of this Act, in addition to the number of full-time equivalent
- 21 (FTE) employees other law authorizes the department to employ
- 22 during that period, the Department of Public Safety may employ out
- 23 of money appropriated by Subsection (c) of this section 79
- 24 full-time equivalent (FTE) employees.
- 25 SECTION 4. DEPARTMENT OF CRIMINAL JUSTICE. The amount of
- 26 \$273,700,000 is appropriated from the general revenue fund to the
- 27 Department of Criminal Justice for the purpose of providing funding

- 1 for correctional security operations during the two-year period
- 2 beginning on the effective date of this Act.
- 3 SECTION 5. COMMISSION ON JAIL STANDARDS. (a) The amount of
- 4 \$214,785 is appropriated from the general revenue fund to the
- 5 Commission on Jail Standards for the purpose of providing funding
- 6 to pay additional full-time equivalent (FTE) employees, increased
- 7 employee overtime compensation costs, and increased travel
- 8 expenses during the two-year period beginning on the effective date
- 9 of this Act.
- 10 (b) During the two-year period beginning on the effective
- 11 date of this Act, in addition to the number of full-time equivalent
- 12 (FTE) employees other law authorizes the commission to employ
- 13 during that period, the Commission on Jail Standards may employ out
- 14 of money appropriated by Subsection (a) of this section three
- 15 full-time equivalent (FTE) employees.
- 16 SECTION 6. TRUSTEED PROGRAMS WITHIN THE OFFICE OF THE
- 17 GOVERNOR. (a) The amount of \$1,020,290,860 is appropriated from
- 18 the general revenue fund to the Trusteed Programs within the Office
- 19 of the Governor for the purpose of providing funding for border
- 20 security operations through the making of border security grants
- 21 during the two-year period beginning on the effective date of this
- 22 Act.
- 23 (b) The money appropriated by Subsection (a) of this section
- 24 may not be used to:
- 25 (1) acquire property through the exercise of eminent
- 26 domain; or
- 27 (2) build a barrier along this state's international

- $1\,$ border with Mexico on property acquired through the exercise of
- 2 eminent domain.
- 3 (c) The amount of \$3,765,000 is appropriated from the
- 4 general revenue fund to the Trusteed Programs within the Office of
- 5 the Governor for the purpose of providing funding for additional
- 6 full-time equivalent (FTE) employees and for additional training
- 7 regarding the handling of misdemeanor and felony crimes for
- 8 eligible prosecuting attorneys, as defined by Section 772.0071(a),
- 9 Government Code, during the two-year period beginning on the
- 10 effective date of this Act.
- 11 (d) Out of money appropriated by Subsection (a) of this
- 12 section, the amount of \$14,000,000 in each state fiscal year of the
- 13 state fiscal biennium beginning September 1, 2021, may be used only
- 14 to provide funding for grants to counties adjacent to this state's
- 15 international border with Mexico to cover those counties' costs for
- 16 additional law enforcement personnel and equipment, overtime pay
- 17 for law enforcement personnel, and other expenses related to
- 18 non-citizens held in county jail facilities, and for non-citizen
- 19 autopsies.
- 20 SECTION 7. DEPARTMENT OF STATE HEALTH SERVICES. (a) The
- 21 amount of \$5,450,976 is appropriated from the general revenue fund
- 22 to the Department of State Health Services for the purpose of
- 23 purchasing ambulance services during the two-year period beginning
- 24 on the effective date of this Act.
- 25 (b) The amount of \$10,901,952 is appropriated from the
- 26 general revenue fund to the Department of State Health Services for
- 27 the purpose of purchasing ambulance services for use at two border

- 1 security processing centers during the two-year period beginning on
- 2 the effective date of this Act.
- 3 SECTION 8. BORDER SECURITY REPORTING REQUIREMENT. (a) In
- 4 this section, "border security" means activities associated with
- 5 deterring crimes and enforcing state laws related to offenses
- 6 listed in Section 772.0071, Government Code, hunting and fishing
- 7 laws related to poaching, laws for which this state receives
- 8 federal grants intended to enhance law enforcement, or laws that
- 9 relate to federal law enforcement operations, between designated
- 10 entry and exit points in counties:
- 11 (1) adjacent to or a portion of which are located
- 12 within 20 miles of an international border;
- 13 (2) adjacent to two counties located on an
- 14 international border with a population of more than 5,000 and less
- 15 than 7,500 according to the most recent federal decennial census;
- 16 (3) adjacent to the Gulf Intracoastal Waterway, as
- 17 defined by Section 51.002, Transportation Code; or
- 18 (4) included in a disaster declaration relating to
- 19 border security issued by the governor.
- 20 (b) The Department of Public Safety, Military Department,
- 21 Trusteed Programs within the Office of the Governor, Department of
- 22 Criminal Justice, Commission on Jail Standards, and Office of Court
- 23 Administration, Texas Judicial Council, shall report all budgeted
- 24 and expended amounts and performance indicator results for border
- 25 security to the Legislative Budget Board.
- 26 (c) The entities described by Subsection (b) of this section
- 27 shall provide the report required by that subsection on a quarterly

- 1 basis and in the manner prescribed by the Legislative Budget Board.
- 2 Each report must include, at a minimum:
- 3 (1) expended amounts and performance indicators for
- 4 activities related to enforcing laws described by Subsection (a) of
- 5 this section that occur:
- 6 (A) in each county described by Subsection (a) of
- 7 this section as well as for statewide activities that support
- 8 border security; or
- 9 (B) in any geographic region outside of the
- 10 counties described by Subsection (a) of this section, as requested,
- 11 such as areas identified as smuggling corridors;
- 12 (2) the method of finance of budgeted and expended
- 13 amounts;
- 14 (3) the object of expense of budgeted and expended
- 15 amounts;
- 16 (4) regular and overtime pay;
- 17 (5) the quarterly total number of border
- 18 security-related apprehensions and arrests made by state law
- 19 enforcement personnel deployed to geographic regions included in
- 20 the areas described by Subsection (a) of this section, including
- 21 the number of minors apprehended;
- 22 (6) the total quarterly number of individuals
- 23 undergoing magistration, prosecution, or conviction for state
- 24 crimes related to border security;
- 25 (7) the total quarterly number of individuals confined
- 26 to state correctional facilities converted by the Department of
- 27 Criminal Justice to confine those accused of state crimes related

- 1 to border security;
- 2 (8) the quarterly total length, expressed in miles,
- 3 and type of temporary and permanent fencing, barrier, or wall
- 4 erected along the international border with Mexico; and
- 5 (9) the quarterly total number and amount of grants
- 6 issued by the Trusteed Programs within the Office of the Governor to
- 7 local jurisdictions and counties included in the area described by
- 8 Subsection (a) of this section.
- 9 SECTION 9. EFFECTIVE DATE. This Act takes effect
- 10 immediately.
