## A BILL TO BE ENTITLED

1	AN ACT
2	relating to air quality permits issued by the Texas Commission on
3	Environmental Quality for certain oil and gas facilities.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter C, Chapter 382, Health and Safety
6	Code, is amended by adding Section 382.051965 to read as follows:
7	Sec. 382.051965. INSPECTION AND MAINTENANCE REQUIREMENTS
8	FOR OIL AND GAS FACILITIES. (a) A permit by rule or a standard
9	permit relating to a facility described by Section 382.051961(a)
10	must require:
11	(1) the permit holder of a new facility or an existing
12	facility that has been modified to establish a quarterly inspection
13	and maintenance program for the detection and repair of leaks from
14	all valves, pump seals, flanges, compressor seals, pressure relief
15	valves, open-ended lines, tanks, and other process and operation
16	components of the facility that could result in fugitive emissions;
17	(2) for a new facility, a prohibition on the use of
18	venting and limitations on the use of flaring;
19	(3) for an existing facility that has been modified,
20	the elimination of the use of venting and a reduction in the use of
21	flaring;
22	(4) limitations on emissions of volatile organic
23	compounds from storage tanks that have the potential to emit more
24	than one ton of volatile organic compounds per year;

- 1 (5) limitations on emissions of nitrogen oxides from
- 2 compressor engines with more than 100 horsepower;
- 3 (6) maintenance protocols and best practices for
- 4 compressor stations; and
- 5 (7) the use and maintenance of no-bleed and low-bleed
- 6 pneumatic devices and controllers between a wellhead and a natural
- 7 gas processing plant and the monitoring of emissions from those
- 8 devices.
- 9 (b) A program described by Subsection (a)(1) must require
- 10 the use of leak detection equipment such as optical gas imaging
- 11 cameras.
- 12 (c) In adopting rules to implement this section, the
- 13 commission may consider:
- 14 (1) applying different standards to new facilities and
- 15 <u>facilities that have been modified; and</u>
- 16 (2) using incentives to encourage the use of best
- 17 practices at facilities subject to this section.
- 18 SECTION 2. Not later than September 1, 2022, the Texas
- 19 Commission on Environmental Quality shall adopt rules as necessary
- 20 to implement Section 382.051965, Health and Safety Code, as added
- 21 by this Act.
- SECTION 3. This Act takes effect on the 91st day after the
- 23 last day of the legislative session.
