Section 303.042(f), Local Government Code, is 6 7 amended to read as follows: (f) Notwithstanding Subsections (a) and (b) and except as 8 9 provided by Section 303.0425, during the period of time that a corporation owns a particular public facility, a leasehold or other 10 possessory interest in the real property of the public facility 11 12 granted by the corporation shall be treated in the same manner as a leasehold or other possessory interest in real property granted by 13 14 an authority under Section 379B.011(b). SECTION 2. Subchapter B, Chapter 303, Local Government 15 16 Code, is amended by adding Section 303.0425 to read as follows: Sec. 303.0425. REQUIREMENTS FOR BENEFICIAL TAX TREATMENT 17 RELATING TO CERTAIN PUBLIC FACILITIES. (a) In this section: 18 (1) "Housing choice voucher program" means the housing 19 choice voucher program under Section 8, United States Housing Act 20 of 1937 (42 U.S.C. Section 1437f). 21 22 (2) "Housing facility" means a public facility being 23 developed or used to provide multifamily housing. 24 (3) "Housing facility user" means a private developer

1	or other private entity that has a leasehold or other possessory
2	interest in a housing facility.
3	(b) Section 303.042(f) applies to a leasehold or other
4	possessory interest in a housing facility granted to a housing
5	facility user only if the housing facility user meets the
6	requirements of this section.
7	(c) Section 303.042(f) does not apply to ad valorem taxes
8	imposed by a school district on a leasehold or other possessory
9	interest in a housing facility granted to a housing facility user.
10	(d) A housing facility user may not:
11	(1) refuse to rent a residential unit in the housing
12	facility to an individual or family because the individual or
13	family participates in the housing choice voucher program; or
14	(2) use a financial or minimum income standard that
15	requires an individual or family participating in the housing
16	choice voucher program to have a monthly income of more than 250
17	percent of the individual's or family's share of the total monthly
18	rent payable for a residential unit.
19	SECTION 3. Section 303.0425, Local Government Code, as
20	added by this Act, applies only to a leasehold or other possessory
21	interest in a housing facility granted by a public facility
22	corporation to a housing facility user on or after the effective
