5	SECTION 1. Chapter 544, Insurance Code, is amended by
6	adding Subchapter O to read as follows:
7	SUBCHAPTER O. VACCINATION STATUS
8	Sec. 544.701. APPLICABILITY OF SUBCHAPTER. (a) This
9	subchapter applies to the issuer of a health benefit plan that
10	provides benefits for medical or surgical expenses incurred as a
11	result of a health condition, accident, or sickness, including a
12	group, blanket, or franchise insurance policy or insurance
13	agreement, a group hospital service contract, or a group evidence
14	of coverage or similar coverage document that is offered by:
15	(1) an insurance company;
16	(2) a group hospital service corporation operating
17	under Chapter 842;
18	(3) a health maintenance organization operating under
19	Chapter 843;
20	(4) an approved nonprofit health corporation that
21	holds a certificate of authority under Chapter 844;
22	(5) a multiple employer welfare arrangement that holds
23	a certificate of authority under Chapter 846;
24	(6) a stipulated premium company operating under

2	(7) a fraternal benefit society operating under
3	Chapter 885;
4	(8) a Lloyd's plan operating under Chapter 941; or
5	(9) an exchange operating under Chapter 942.
6	(b) Notwithstanding any other law, this subchapter applies
7	<u>to:</u>
8	(1) a small employer health benefit plan subject to
9	Chapter 1501, including coverage provided through a health group
10	cooperative under Subchapter B of that chapter; and
11	(2) a standard health benefit plan issued under
12	<u>Chapter 1507.</u>
13	(c) This subchapter applies to a life insurance company
14	that:
15	(1) issues or delivers a life insurance policy in this
16	state; or
17	(2) is organized under the laws of this state.
18	(d) This subchapter applies to an insurer offering a
19	property and casualty insurance policy to a business entity.
20	Sec. 544.702. VACCINATION REQUIREMENTS PROHIBITED. An
21	insurer or other issuer offering a health benefit plan, life
22	insurance policy, property and casualty insurance policy, or any
23	other insurance policy written for business entities may not
24	discriminate against an employee without a vaccination by requiring
25	as a condition to purchase or maintain coverage, including an
26	endorsement, that each of the business's employees is vaccinated.
27	SECTION 2. Subchapter O, Chapter 544, Insurance Code, as

1 added by this Act, applies only to a health benefit plan or 2 insurance policy delivered, issued for delivery, or renewed on or 3 after January 1, 2022.

4 SECTION 3. This Act takes effect on the 91st day after the 5 last day of the legislative session.
