5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Chapter 161, Health and Safety Code, is amended
7	by adding Subchapter X to read as follows:

10	Sec. 161.701. DEFINITIONS. In this subchapter:
11	(1) "Child" means an individual who is younger than 18
12	years of age.
13	(2) "Health care provider" means a person other than a
14	physician who is licensed, certified, or otherwise authorized by
15	the laws of this state to provide or render health care or to
16	dispense or prescribe a prescription drug in the ordinary course of
17	business or practice of a profession.
18	(3) "Physician" means a person licensed to practice
19	medicine in this state.

         Sec. 161.703. EXCEPTIONS. (a) Section 161.702 does not
   apply to a physician's or health care provider's provision, with the

- SECTION 2. Subchapter F, Chapter 1901, Insurance Code, is
- 24 amended by adding Section 1901.256 to read as follows:
- Sec. 1901.256. PROHIBITED COVERAGE FOR PROVISION OF CERTAIN
- 26 GENDER-RELATED PROCEDURES AND TREATMENTS TO CERTAIN CHILDREN. A
- 27 professional liability insurance policy issued to a physician or

- 1 health care provider may not include coverage for damages assessed
- 2 against the physician or health care provider who provides to a
- 3 child gender transitioning or gender reassignment procedures or
- 4 treatments that are prohibited by Section 161.702, Health and
- 5 Safety Code.
- 6 SECTION 3. Section 1901.256, Insurance Code, as added by
- 7 this Act, applies only to a medical professional liability
- 8 insurance policy that is delivered, issued for delivery, or renewed
- 9 on or after April 1, 2022. An insurance policy that is delivered,
- 10 issued for delivery, or renewed before April 1, 2022, is governed by
- 11 the law in effect immediately before the effective date of this Act,
- 12 and that law is continued in effect for that purpose.
- 13 SECTION 4. This Act takes effect immediately if it receives
- 14 a vote of two-thirds of all the members elected to each house, as
- 15 provided by Section 39, Article III, Texas Constitution. If this
- 16 Act does not receive the vote necessary for immediate effect, this
- 17 Act takes effect on the 91st day after the last day of the
- 18 legislative session.
