H.B. No. 192

A BILL TO BE ENTITLED

1 AN ACT
2 relating to the eligibility of the Professional Bull Riders World
3 Finals for funding under the Major Events Reimbursement Program.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Sections 478.0001(3) and (7), Government Code,
6 as amended by H.B. 1472, H.B. 3607, S.B. 1155, and S.B. 1265, Acts
7 of the 87th Legislature, Regular Session, 2021, and effective
8 September 1, 2021, are reenacted and amended to read as follows:

23 Championship;

24 (I) [~~(H)~~] a Formula One automobile race;

1 (J) [~~(I)~~] the largest event held each year at a
2 sports entertainment venue in this state with a permanent seating
3 capacity, including grandstand and premium seating, of at least
4 125,000 on September 1, 2021;

5 (K) [~~(J)~~] the Major League Baseball All-Star
6 Game;

7 (L) [~~(K)~~] the Major League Soccer All-Star Game
8 or the Major League Soccer Cup;

9 (M) [~~(L)~~] a mixed martial arts championship;

10 (N) [~~(M)~~] the Moto Grand Prix of the United
11 States;

12 (O) [~~(N)~~] the National Association for Stock Car
13 Auto Racing (NASCAR):

14 (i) All-Star Race;

15 (ii) season-ending Championship Race; or

16 (iii) Texas Grand Prix race;

17 (P) [~~(O)~~] the National Basketball Association
18 All-Star Game;

19 (Q) [~~(P)~~] a National Collegiate Athletic
20 Association Final Four tournament game;

21 (R) [~~(Q)~~] the National Collegiate Athletic
22 Association men's or women's lacrosse championships;

23 (S) [~~(R)~~] a national collegiate championship of
24 an amateur sport sanctioned by the national governing body of the
25 sport that is recognized by the United States Olympic Committee;

26 (T) [~~(S)~~] the National Cutting Horse Association
27 Triple Crown;

1 (U) [~~(T)~~] the National Hockey League All-Star
2 Game;

3 (V) the National Hot Rod Association Fall
4 Nationals at the Texas Motorplex;

5 (W) [~~(U)~~] a national political convention of the
6 Republican National Committee or the Democratic National
7 Committee;

8 (X) [~~(V)~~] a championship event in the National
9 Reined Cow Horse Association (NRCHA) Championship Series;

10 (Y) [~~(W)~~] an Olympic activity, including a
11 Junior or Senior activity, training program, or feeder program
12 sanctioned by the United States Olympic Committee's Community
13 Olympic Development Program;

14 (Z) [~~(X)~~] a presidential general election
15 debate;

16 (AA) the Professional Bull Riders World Finals;

17 (BB) [~~(Y)~~] the Professional Rodeo Cowboys
18 Association National Finals Rodeo;

19 (CC) [~~(Z)~~] a Super Bowl;

20 (DD) [~~(AA)~~] the United States Open Championship;

21 (EE) [~~(BB)~~] a World Cup soccer game or the World
22 Cup soccer tournament;

23 (FF) [~~(CC)~~] the World Games;

24 (GG) [~~(DD)~~] a World Wrestling Entertainment
25 WrestleMania event; or

26 (HH) [~~(EE)~~] the X Games.

27 (7) "Site selection organization" means:

5 LLC, or its successor;
- 6 (E) the Commission on Presidential Debates;

8 and Caribbean Association Football (Concacaf);
- 9 (G) [~~(F)~~] the Democratic National Committee;
- 10 (H) [~~(G)~~] Dorna Sports;
- 11 (I) [~~(H)~~] the Elite Rodeo Association;
- 12 (J) [~~(I)~~] Encore Live;
- 13 (K) [~~(J)~~] ESPN or an affiliate;
- 14 (L) [~~(K)~~] the Federation Internationale de
15 Football Association (FIFA);
- 16 (M) [~~(L)~~] the International World Games
17 Association;
- 18 (N) [~~(M)~~] Major League Baseball;
- 19 (O) [~~(N)~~] Major League Soccer;
- 20 (P) [~~(O)~~] the National Association for Stock Car
21 Auto Racing (NASCAR);
- 22 (Q) [~~(P)~~] the National Basketball Association;
- 23 (R) [~~(Q)~~] the National Collegiate Athletic

- 27 (T) [~~(S)~~] the National Football League;

1 (U) [~~(T)~~] the National Hockey League;
2 (V) the National Hot Rod Association;
3 (W) [~~(U)~~] the National Reined Cow Horse
4 Association (NRCHA);
5 (X) Professional Bull Riders, LLC;
6 (Y) [~~(V)~~] the Professional Rodeo Cowboys
7 Association;
8 (Z) [~~(W)~~] the Republican National Committee;
9 (AA) [~~(X)~~] the Ultimate Fighting Championship;
10 (BB) [~~(Y)~~] the United States Golf Association;
11 (CC) [~~(Z)~~] the United States Olympic Committee;
12 (DD) [~~(AA)~~] World Wrestling Entertainment; or
13 (EE) [~~(BB)~~] the national governing body of a
14 sport that is recognized by:

- 15 (i) the Federation Internationale de
16 l'Automobile;
17 (ii) Formula One Management Limited;
18 (iii) the National Thoroughbred Racing
19 Association; or
20 (iv) the United States Olympic Committee.

21 SECTION 2. If this Act receives a vote of two-thirds of all
22 the members elected to each house, as provided by Section 39,
23 Article III, Texas Constitution, this Act takes effect on the first
24 day that occurs after August 31, 2021, and is on or after the
25 earliest date on which this Act may take effect. If this Act does
26 not receive the vote necessary for effect on that date, this Act
27 takes effect on the 91st day after the last day of the legislative
