## A BILL TO BE ENTITLED 1 AN ACT 2 relating to accommodating voters with a disability. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 63.0015, Election Code, is amended by 4 5 amending Subsections (b), (c), and (d) and adding Subsection (f) to 6 read as follows: An election officer shall [may] accept a person with a 7 (b) mobility problem that substantially impairs a person's ability to 8 ambulate who is offering to vote before accepting others offering 9 to vote at the polling place who arrived before the person. 10 11 Notice of the priority given to persons with a mobility (c) 12 problem that substantially impairs a person's ability to ambulate shall be posted: 13 14 (1) at [one or more locations in] each entrance to a polling place where it can be read by persons waiting to vote; 15 16 (2) on the Internet website of the secretary of state; and 17 18 (3) on each Internet website relating to elections maintained by a county. 19 The notice required by Subsection (c) must read: 20 (d) 21 "Pursuant to Section 63.0015, Election Code, an election officer shall [may] give voting order priority to individuals with a 22 23 mobility problem that substantially impairs the person's ability to move around. A person assisting an individual with a mobility 24

problem may also, at the individual's request, be given voting 1 order priority. Disabilities and conditions that may qualify you 2 3 for voting order priority include paralysis, lung disease, the use of portable oxygen, cardiac deficiency, severe limitation in the 4 5 ability to walk due to arthritic, neurological, or orthopedic condition, wheelchair confinement, arthritis, foot disorder, the 6 inability to walk 200 feet without stopping to rest, or use of a 7 8 brace, cane, crutch, or other assistive device."

9 (f) All procedures and accommodations related to voting 10 available for voters with disabilities, including voting under 11 Section 64.009, shall be posted in an accessible manner on the 12 county clerk's Internet website.

13 SECTION 2. Section 64.009, Election Code, is amended by 14 adding Subsection (e) to read as follows:

15 (e) At each polling place two parking spaces shall be 16 reserved for voting under this section. The spaces may not be 17 parking spaces designated specifically for persons with 18 disabilities. The parking spaces must be clearly marked for use by a 19 voter who is unable to enter the polling place with a sign. The sign 20 must have a telephone number that a voter may call or text to 21 request assistance from election officials at the polling place.

SECTION 3. Section 84.011(a), Election Code, as effective September 1, 2021, is amended to read as follows:

(a) The officially prescribed application form for an earlyvoting ballot must include:

26 (1) immediately preceding the signature space the27 statement: "I certify that the information given in this

Application is true, and I understand that giving false information
in this application is a crime.";

3 (2) a statement informing the applicant of the
4 offenses prescribed by Sections 84.003 and 84.004;

5 (3) spaces for entering an applicant's voter 6 registration number and county election precinct of registration, 7 with a statement informing the applicant that failure to furnish 8 that information does not invalidate the application; and

9 (4) on an application for a ballot to be voted by mail: 10 (A) a space for an applicant applying on the 11 ground of absence from the county of residence to indicate the date 12 on or after which the applicant can receive mail at the address 13 outside the county;

(B) a space for indicating the fact that an applicant whose application is signed by a witness cannot make the applicant's mark and a space for indicating the relationship or lack of relationship of the witness to the applicant;

(C) a space for entering an applicant's telephone
number, with a statement informing the applicant that failure to
furnish that information does not invalidate the application;

(D) a space or box for an applicant applying on the ground of age or disability to indicate that the address to which the ballot is to be mailed is the address of a facility or relative described by Section 84.002(a)(3), if applicable;

(E) a space or box for an applicant applying on the ground of confinement in jail or involuntary civil commitment to indicate that the address to which the ballot is to be mailed is

No. 221 1 the address of a relative described by Section 84.002(a)(4) or (7), if applicable; 2 3 (F) a space for an applicant applying on the ground of age or disability to indicate if the application is an 4 5 application under Section 86.0015; 6 (G) spaces for entering the signature, printed 7 name, and residence address of any person assisting the applicant; 8 (H) a statement informing the applicant of the condition prescribed by Section 81.005; [and] 9 10 (I) a statement informing the applicant of the requirement prescribed by Section 86.003(c); and 11 12 (J) a space or box for an applicant applying on the ground of disability to indicate that the voter would like to 13 14 receive a ballot under Section 86.0035. 15 SECTION 4. Subchapter A, Chapter 84, Election Code, is amended by adding Section 84.0121 to read as follows: 16 17 Sec. 84.0121. CLERK TO POST APPLICATION FORM ONLINE. (a) The early voting clerk shall post the official application form for 18 19 an early voting ballot on the clerk's Internet website in a format that allows a person to easily complete the application directly on 20 the website before printing. 21 (b) The early voting clerk may use the application form 22 provided by the secretary of state under Section 84.013 or the early 23 24 voting clerk's own application form. SECTION 5. Section 84.013, Election Code, is amended to 25 26 read as follows: Sec. 84.013. APPLICATION FORMS FURNISHED BY SECRETARY OF 27

1 STATE. (a) The secretary of state shall maintain a supply of the 2 official application forms for ballots to be voted by mail and shall 3 furnish the forms in reasonable quantities without charge to 4 individuals or organizations requesting them for distribution to 5 voters.

6 (b) The secretary of state shall provide a printable 7 application for a ballot by mail in a format that complies with 8 Section 84.0121(a) to the early voting clerk for use under that 9 section.

10 SECTION 6. Section 86.003, Election Code, is amended by 11 amending Subsection (a) and adding Subsection (e) to read as 12 follows:

(a) <u>Except as provided by Subsection (e), the</u> [The] balloting materials for voting by mail shall be provided to the voter by mail. A ballot provided by any other method may not be counted.

17 (e) If a voter is eligible for early voting by mail on the 18 ground of disability, the balloting materials may be provided in 19 accordance with Section 86.0035.

20 SECTION 7. Chapter 86, Election Code, is amended by adding 21 Section 86.0035 to read as follows:

22 <u>Sec. 86.0035. DIGITAL REMOTE VOTING. (a) In this section,</u> 23 <u>"tactile marking" means a method of identifying certain materials</u> 24 <u>based on touch, and includes a hole punch, a cut corner, or a</u> 25 <u>tactile sticker.</u>

26 (b) The secretary of state shall implement a program to 27 allow a voter eligible for early voting on the ground of disability

1 to remotely receive and mark an early voting ballot to be voted by 2 mail using assistive technology equipment. 3 (c) The program implemented under this section must allow a voter to receive and mark an early voting ballot to be voted by mail 4 5 without assistance. (d) Section 86.010 applies to a voter voting a ballot under 6 7 this section. (e) Subject to Subsection (h), a voter receiving and marking 8 a ballot under this section shall print the marked ballot and return 9 10 it in a manner provided by Section 86.006. 11 (f) If a voter receives a ballot under this section, the 12 early voting clerk shall provide an official ballot envelope and carrier envelope to the voter by mail. The ballot envelope and 13 carrier envelope must include tactile marking to help the voter 14 identify and distinguish between the envelopes. 15 (g) A ballot under this section may not be rejected under 16 17 Subchapter C, Chapter 87, on the sole basis that: (1) the marked ball<u>ot is printed on regular paper; or</u> 18 19 (2) the voter's signature is not in the correct location on the carrier envelope, if the voter's signature is 20 clearly visible and determined to be the signature of the voter. 21 22 (h) The secretary of state shall adopt rules and procedures to implement this section. Rules adopted under this subsection may 23 24 include rules providing for an additional secure method of returning a ballot under this section. 25 26 SECTION 8. Section 104.004(e), Election Code, is amended to read as follows: 27

1 (e) If the voter is physically unable to enter the early 2 voting polling place without personal assistance or a likelihood of 3 injuring the voter's health, the clerk shall deliver the balloting 4 materials to the voter at the polling place entrance or curb 5 <u>following the procedures prescribed by Section 64.009</u>.

6 SECTION 9. This Act takes effect immediately if it receives 7 a vote of two-thirds of all the members elected to each house, as 8 provided by Section 39, Article III, Texas Constitution. If this 9 Act does not receive the vote necessary for immediate effect, this 10 Act takes effect on the 91st day after the last day of the 11 legislative session.
