CONCURRENT RESOLUTION

1 WHEREAS, The 2020 election took place amidst 2 unprecedented challenges of a global pandemic, but local and state administrators rose to the occasion, embracing measures that 3 allowed a record number of Americans to make their voices heard in a 4 5 safe, secure, and professional process; and WHEREAS, The For the People Act currently under consideration 6 7 in the United States Congress reflects lessons learned across the country during recent election cycles, embracing measures to 8 9 improve the safety and security of our voting processes and to strengthen our democracy by engaging more citizens; recognizing the 10 11 exigencies of modern life in a 24/7 economy, the legislation 12 includes many elements to make voting simpler and more convenient, among them at least two weeks of early in-person voting, online and 13 14 same-day voter registration, and automatic voter registration at motor vehicle departments and other specified government agencies; 15 16 it expands and standardizes voting by mail, provides funding for mail-in ballot tracking, and offers standards for ballot drop 17 boxes; setting such national policies will ensure that every 18 eligible voter has equal access to the ballot box, no matter where 19 20 they reside; and 21 WHEREAS, Described by the League of Women Voters as "the most expansive democracy reform legislation we have seen since the 22 23 Voting Rights Act," the For the People Act also bolsters election security, ensuring that elections are decided by American voters 24

- 1 without interference from foreign adversaries; it creates a
- 2 national strategy to protect our democratic institutions,
- 3 increases oversight of election vendors, and improves federal
- 4 support for state voting system security upgrades, including paper
- 5 ballot voting systems; by requiring states to adopt independent
- 6 redistricting commissions, it ensures that voters choose their
- 7 representatives, not the other way around; moreover, it addresses
- 8 the dominance of big money and special interests in politics by
- 9 increasing transparency, bolstering oversight by the Federal
- 10 Election Commission, and fortifying ethics laws and enforcement for
- 11 violations; and
- 12 WHEREAS, The provisions in the For the People Act enjoy
- 13 overwhelming public support; a recent Global Strategy Group/ALG
- 14 Research survey of likely general election voters in a dozen states
- 15 found 83 percent agreement for the bill, with provisions to reduce
- 16 the influence of money in politics receiving nearly universal
- 17 support; and
- WHEREAS, Americans can take great pride in the resiliency of
- 19 our electoral system and the determination of the voting public
- 20 even in the face of historic upheaval, and by passing this
- 21 legislation, Congress can provide an even sturdier foundation for
- 22 government of the people, by the people, and for the people; now,
- 23 therefore, be it
- 24 RESOLVED, That the 87th Legislature of the State of Texas,
- 25 2nd Called Session, hereby respectfully urge the United States
- 26 Congress to pass the For the People Act; and, be it further
- 27 RESOLVED, That the Texas secretary of state forward official
