4 WHEREAS, Born on February 14, 1931, in Rosenberg, Ed Walker
5 was the son of Luther and Juanita Walker and grew up with the
6 companionship of his brother, Bob; he graduated from Pine Tree High
7 School in 1949, and after a year in college, he answered his
8 nation's call to duty, serving in the U.S. Navy for four years; and

10 Warden Training Academy, and he subsequently embarked on a long and
11 rewarding career as a game warden; an avid outdoorsman, he loved to
