- 1 WHEREAS, A full and generous life drew to a close with the
- 2 death of Joseph LaMantia Jr. of McAllen on June 14, 2021, at the age
- 3 of 88; and
- 4 WHEREAS, Joe LaMantia was born to Joseph and Verna LaMantia
- 5 in 1933, and he grew up in South Texas with five sisters, Marie,
- 6 Ann, Shirley, Verna, and Joan; his family settled in the Rio Grande
- 7 Valley in 1965, and in 1977 Mr. LaMantia started L&F Distributors,
- 8 a wholesale beer distribution company which has since grown to
- 9 encompass seven locations with nearly 1,100 employees serving 53
- 10 counties across the Lone Star State; and
- 11 WHEREAS, A longtime champion of education, Mr. LaMantia
- 12 established one of the first scholarships for women athletes at The
- 13 University of Texas-Pan American, and the scholarship was named for
- 14 his first wife, Ann LaMantia, who passed away in 1983; in addition,
- 15 L&F Distributors raised more than \$5 million over eight years for
- 16 the Hispanic Scholarship Fund, and in 2002 he established the Stars
- 17 Scholarship Fund, which has disbursed over \$35 million to more than
- 18 17,000 students in South and West Texas; and
- 19 WHEREAS, Mr. LaMantia served on the board of the Texas
- 20 Department of Corrections for 15 years, and he was an active
- 21 supporter of the Rio Grande Cancer Treatment Research Foundation,
- 22 the American Heart Association, the South Texas Communities for
- 23 Youth Service, and the Special Olympics, among many other
- 24 worthwhile organizations; he was recognized as Border Texan of the

- 1 Year and as a Distinguished Citizen by the Boy Scouts of America Rio
- 2 Grande Council, and his numerous other honors include the Citizen
- 3 of the Year award from The University of Texas Health Science Center
- 4 at San Antonio, the Bridge Builder Award from UTPA, and the Golden
- 5 Eagle Award from the Rio Grande Valley Hispanic Chamber of
- 6 Commerce; and
- WHEREAS, Following the death of his first wife, Mr. LaMantia
- 8 went on to share a rewarding marriage with Derrelene LaMantia that
- 9 spanned 36 years; he was a devoted father to his children, Val, Joe,
- 10 Greg, Steve, and Tony, and his stepchildren, Jennifer and Lori, and
- 11 he was eventually blessed with many grandchildren and
- 12 great-grandchildren; and
- WHEREAS, A leader in his community, a successful
- 14 entrepreneur, and a generous philanthropist, Joe LaMantia leaves
- 15 behind a record of service that will continue to inspire all those
- 16 who were privileged to know him; now, therefore, be it

- 18 Legislature, 2nd Called Session, hereby pay tribute to the memory
- 19 of Joseph LaMantia Jr. and extend heartfelt sympathy to his family
