 1-20 AN ACT

1-21 relating to election integrity and security, including by
 1-22 preventing fraud in the conduct of elections in this state;
 1-23 increasing criminal penalties; creating criminal offenses;
 1-24 providing civil penalties.

1-25 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-26 ARTICLE 1. REGISTRATION OF VOTERS

1-27 SECTION 1.01. Section 13.002, Election Code, is amended by
 1-28 adding Subsection (c-1) to read as follows:

1-29 (c-1) The information required under Subsections (c)(3),
 1-30 (4), (5), (6), and (8) must be supplied by the person desiring to
 1-31 register to vote.

1-32 SECTION 1.02. Section 15.021, Election Code, is amended by
 1-33 amending Subsections (b) and (d) and adding Subsections (d-1) and
 1-34 (d-2) to read as follows:

1-35 (b) Except as provided by Subsection (d), the [The] voter
 1-36 shall use the registration certificate or a registration
 1-37 application form as the notice, indicating the correct information
 1-38 in the appropriate space on the certificate or application form
 1-39 unless the voter does not have possession of the certificate or an
 1-40 application form at the time of giving the notice.

1-41 (d) A voter ~~[who continues to reside in the county in which~~
 1-42 ~~the voter is registered]~~ may correct information under this section
 1-43 by digital transmission of the information under a program
 1-44 administered by the secretary of state and the Department of
 1-45 Information Resources.

1-46 (d-1) If the notice indicates that a voter no longer resides
 1-47 in the county in which the voter is registered, the registrar shall
 1-48 forward the notice and the voter's application for registration to
 1-49 the registrar of the county in which the voter resides. The
 1-50 registrars shall coordinate to ensure that the voter's existing
 1-51 registration is canceled immediately after the voter is registered
 1-52 in the county in which the voter resides in accordance with
 1-53 Subsection (d-2).

1-54 (d-2) A registrar who receives a voter's notice and
 1-55 application from another registrar under Subsection (d-1) shall
 1-56 treat it as an original application for registration under Section
 1-57 13.002, and shall register the voter if the voter resides in the
 1-58 county and is otherwise eligible under Section 13.001.

1-59 SECTION 1.03. Section 15.028, Election Code, is amended to
 1-60 read as follows:

2-1 Sec. 15.028. NOTICE OF UNLAWFUL VOTING OR REGISTRATION ~~[TO~~
 2-2 ~~PROSECUTOR]~~. ~~[(a)]~~ If the registrar determines that a person who
 2-3 is not eligible to vote registered to vote or [a registered voter]
 2-4 voted in an election, the registrar shall execute and deliver to the
 2-5 attorney general, the secretary of state, and the county or
 2-6 district attorney having jurisdiction in the territory covered by
 2-7 the election an affidavit stating the relevant facts.

2-8 ~~[(b) If the election covers territory in more than one~~
 2-9 ~~county, the registrar shall also deliver an affidavit to the~~
 2-10 ~~attorney general.]~~

2-11 SECTION 1.04. Section 16.0332, Election Code, is amended by
 2-12 amending Subsection (a) and adding Subsections (a-1), (d), and (e)
 2-13 to read as follows:

2-14 (a) After the registrar receives notification [a list]
 2-15 under Subsection (a-1) of this section, Section 18.068 of this
 2-16 code, or Section 62.113, Government Code, of persons excused or
 2-17 disqualified from jury service because of citizenship status or
 2-18 notification of persons who indicate a lack of citizenship status
 2-19 in connection with a motor vehicle or Department of Public Safety
 2-20 record as provided by Subsection (a-1), the registrar shall deliver
 2-21 to each registered voter whose name appears on the list a written
 2-22 notice requiring the voter to submit to the registrar proof of
 2-23 United States citizenship in the form of a certified copy of the
 2-24 voter's birth certificate, United States passport, or certificate
 2-25 of naturalization or any other form prescribed by the secretary of
 2-26 state. The notice shall be delivered by forwardable mail to the
 2-27 mailing address on the voter's registration application and to any
 2-28 new address of the voter known to the registrar.

2-29 (a-1) The secretary of state shall enter into an agreement
 2-30 with the Department of Public Safety under which information in the
 2-31 existing statewide computerized voter registration list is
 2-32 compared against information in the database of the Department of
 2-33 Public Safety on a monthly basis to verify the accuracy of
 2-34 citizenship status information previously provided on voter
 2-35 registration applications. In comparing information under this
 2-36 subsection, the secretary of state shall consider only a voter's
 2-37 information in the database of the Department of Public Safety that
 2-38 was derived from documents presented by the voter to the department
 2-39 after the person's current voter registration became effective, and
 2-40 may not consider information derived from documents presented by
 2-41 the voter to the department before the person's current voter
 2-42 registration became effective.

2-43 (d) The secretary of state shall prescribe rules for the
 2-44 administration of this section.

2-45 (e) Not later than December 31 of each year, the secretary
 2-46 of state shall provide a report to the legislature of the number of
 2-47 voter registrations canceled under this section during the calendar
 2-48 year.

2-49 SECTION 1.05. Section 18.068, Election Code, is amended by
 2-50 amending Subsection (a) and adding Subsection (a-1) to read as
 2-51 follows:

2-52 (a) The secretary of state shall quarterly compare the
 2-53 information received under Section 16.001 of this code and Sections
 2-54 [Section] 62.113 and 62.114, Government Code, to the statewide
 2-55 computerized voter registration list. If the secretary determines
 2-56 that a voter on the registration list is deceased or has been
 2-57 excused or disqualified from jury service because the voter is not a
 2-58 citizen or a resident of the county in which the voter is registered
 2-59 to vote, the secretary shall send notice of the determination to:

2-60 (1) the voter registrar of the counties considered
 2-61 appropriate by the secretary; and

2-62 (2) the attorney general, who shall quarterly review
 2-63 the information to investigate whether a person has committed an
 2-64 offense under Section 13.007 or other law.

2-65 (a-1) The secretary of state is not required to send notice
 2-66 under Subsection (a) for a voter who is subject to an exemption from
 2-67 jury service under Section 62.106, Government Code, if that
 2-68 exemption is the only reason the voter is excused from jury service.

2-69 SECTION 1.06. Section 31.006, Election Code, is amended to

3-1 read as follows:

3-2 Sec. 31.006. REFERRAL [~~OF COMPLAINT~~] TO ATTORNEY GENERAL.

3-3 (a) If, after receiving or discovering information indicating that
 3-4 [~~a complaint alleging~~] criminal conduct in connection with an
 3-5 election has occurred, the secretary of state determines that there
 3-6 is reasonable cause to suspect that [~~the alleged~~] criminal conduct
 3-7 occurred, the secretary shall promptly refer the information
 3-8 [~~complaint~~] to the attorney general. The secretary shall deliver
 3-9 to the attorney general all pertinent documents and information in
 3-10 the secretary's possession.

3-11 (b) The documents and information submitted under
 3-12 Subsection (a) are not considered public information until:

3-13 (1) the secretary of state makes a determination that
 3-14 the information [~~complaint~~] received does not warrant an
 3-15 investigation; or

3-16 (2) if referred to the attorney general, the attorney
 3-17 general has completed the investigation or has made a determination
 3-18 that the information [~~complaint~~] referred does not warrant an
 3-19 investigation.

3-20 SECTION 1.07. Section 62.113(b), Government Code, is
 3-21 amended to read as follows:

3-22 (b) On the third business day of each month, the clerk shall
 3-23 send a copy of the list of persons excused or disqualified because
 3-24 of citizenship in the previous month to:

3-25 (1) the voter registrar of the county;

3-26 (2) the secretary of state; and

3-27 (3) the attorney general and the county or district
 3-28 attorney [~~, as applicable,~~] for an investigation of whether the
 3-29 person committed an offense under Section 13.007, Election Code, or
 3-30 other law.

3-31 SECTION 1.08. Sections 62.114(b) and (c), Government Code,
 3-32 are amended to read as follows:

3-33 (b) On the third business day of each month, the clerk shall
 3-34 send [~~to the voter registrar of the county~~] a copy of the list of
 3-35 persons excused or disqualified in the previous month because the
 3-36 persons do not reside in the county to:

3-37 (1) the voter registrar of the county;

3-38 (2) the secretary of state; and

3-39 (3) the attorney general and the county or district
 3-40 attorney for an investigation of whether the person committed an
 3-41 offense under Section 13.007, Election Code, or other law.

3-42 (c) A list compiled under this section may not be used for a
 3-43 purpose other than a purpose described by Subsection (b) or Section
 3-44 15.081 or 18.068, Election Code.

3-45 ARTICLE 2. CONDUCT AND SECURITY OF ELECTIONS

3-46 SECTION 2.01. Section 43.031, Election Code, is amended by
 3-47 amending Subsection (b) and adding Subsections (b-1) and (b-2) to
 3-48 read as follows:

3-49 (b) Each polling place shall be located inside a building.
 3-50 Except as provided by Subsection (b-1), a polling place may not be
 3-51 located in a tent or similar temporary moveable structure or in a
 3-52 facility primarily designed for motor vehicles. No voter may cast a
 3-53 vote from inside a motor vehicle unless the voter meets the
 3-54 requirements of Section 64.009.

3-55 (b-1) A polling place may be located in a tent or similar
 3-56 temporary moveable structure if:

3-57 (1) a building selected for a polling place is later
 3-58 determined by the county commissioners court to be not reasonably
 3-59 accessible due to fire, flood, or other natural disaster rendering
 3-60 the building unsafe for public use;

3-61 (2) a suitable substitute building is not available;
 3-62 and

3-63 (3) the tent or similar temporary moveable structure
 3-64 is adjacent to the building described by Subdivision (1).

3-65 (b-2) If the county commissioners court makes a
 3-66 determination described by Subsection (b-1)(1):

3-67 (1) the determination is valid only for the next
 3-68 scheduled election; and

3-69 (2) the court shall send a record of that

4-1 determination to the secretary of state as soon as practicable.

4-2 SECTION 2.02. Section 61.002, Election Code, is amended to
4-3 read as follows:

4-4 Sec. 61.002. OPENING AND CLOSING POLLING PLACE FOR VOTING.

4-5 (a) Immediately before opening the polls for voting on the first
4-6 day of early voting and on election day, the presiding election
4-7 judge or alternate election judge shall confirm that each voting
4-8 machine has any public counter reset to zero and shall print the
4-9 tape that shows the counter was set to zero for each candidate or
4-10 measure on the ballot.

4-11 (b) At the official time for opening the polls for voting,
4-12 an election officer shall open the polling place entrance and admit
4-13 the voters.

4-14 (c) Immediately after closing the polls for voting on
4-15 election day, the presiding election judge or alternate election
4-16 judge shall print the tape to show the number of votes cast for each
4-17 candidate or ballot measure for each voting machine.

4-18 (d) Each election judge or alternate election judge present
4-19 shall sign a tape printed under this section.

4-20 SECTION 2.03. Section 64.007(c), Election Code, is amended
4-21 to read as follows:

4-22 (c) An election officer shall maintain a register of spoiled
4-23 ballots at the polling place, including spoiled ballots from a
4-24 direct recording electronic voting unit. An election officer shall
4-25 enter on the register the name of each voter who returns a spoiled
4-26 ballot and the spoiled ballot's number. The secretary of state
4-27 shall create and promulgate a form to be used for this purpose.

4-28 SECTION 2.04. Subchapter A, Chapter 65, Election Code, is
4-29 amended by adding Section 65.017 to read as follows:

4-30 Sec. 65.017. VOTE TABULATING EQUIPMENT. Beginning January
4-31 1, 2024, equipment to tabulate votes may not be used if any wireless
4-32 connectivity capability of the equipment has not been disabled or
4-33 removed.

4-34 SECTION 2.05. Subchapter A, Chapter 66, Election Code, is
4-35 amended by adding Section 66.004 to read as follows:

4-36 Sec. 66.004. POLLING PLACE CHECKLISTS. The secretary of
4-37 state shall adopt rules and create a checklist or similar
4-38 guidelines to assist the presiding judge of a polling place in
4-39 processing forms and conducting procedures required by this code at
4-40 the opening and closing of the polling place.

4-41 SECTION 2.06. Section 66.052, Election Code, is amended to
4-42 read as follows:

4-43 Sec. 66.052. DELIVERY BY ELECTION CLERK; CHAIN OF CUSTODY.

4-44 (a) A delivery of election records or supplies that is to be
4-45 performed by the presiding judge may be performed by an election
4-46 clerk designated by the presiding judge.

4-47 (b) If the presiding judge of a polling place designates a
4-48 clerk to deliver election supplies, the presiding judge shall
4-49 attest to the designation, and the clerk shall attest to the clerk's
4-50 acceptance of the responsibility. The secretary of state shall
4-51 create and promulgate a form to facilitate compliance with this
4-52 section.

4-53 SECTION 2.07. Section 85.005, Election Code, is amended to
4-54 read as follows:

4-55 Sec. 85.005. REGULAR DAYS AND HOURS FOR VOTING. (a) Except
4-56 as provided by Subsection (c), in an election in which a county
4-57 clerk [~~or city secretary~~] is the early voting clerk under Section
4-58 ~~83.002~~ [~~or 83.005~~], early voting by personal appearance at the main
4-59 early voting polling place shall be conducted on each weekday of
4-60 ~~[the weekdays of]~~ the early voting period that is not a legal state
4-61 holiday and for a period of at least nine hours, except that voting
4-62 may not be conducted earlier than 6 a.m. or later than 9 p.m.
4-63 ~~[during the hours that the county clerk's or city secretary's main~~
4-64 ~~business office is regularly open for business.]~~

4-65 (b) In an election to which Subsection (a) does not apply,
4-66 early voting by personal appearance at the main early voting
4-67 polling place shall be conducted at least nine [~~eight~~] hours each
4-68 weekday of the early voting period that is not a legal state holiday
4-69 unless the territory covered by the election has fewer than 1,000

5-1 registered voters. In that case, the voting shall be conducted at
 5-2 least four [~~three~~] hours each day. The authority ordering the
 5-3 election, or the county clerk if that person is the early voting
 5-4 clerk, shall determine which hours the voting is to be conducted.

5-5 (c) In a county with a population of 30,000 [~~100,000~~] or
 5-6 more, the voting in a primary election or the general election for
 5-7 state and county officers shall be conducted at the main early
 5-8 voting polling place for at least 12 hours on each weekday of the
 5-9 last week of the early voting period, and the voting in a special
 5-10 election ordered by the governor shall be conducted at the main
 5-11 early voting polling place for at least 12 hours on each of the last
 5-12 two days of the early voting period. Voting under this subsection
 5-13 may not be conducted earlier than 6 a.m. or later than 9 p.m. Voting
 5-14 shall be conducted in accordance with this subsection in those
 5-15 elections in a county with a population under 30,000 [~~100,000~~] on
 5-16 receipt by the early voting clerk of a written request for the
 5-17 extended hours submitted by at least 15 registered voters of the
 5-18 county. The request must be submitted in time to enable compliance
 5-19 with Section 85.067.

5-20 (d) A voter who has not voted before the scheduled time for
 5-21 closing a polling place is entitled to vote after that time if the
 5-22 voter is in line at the polling place by closing time. The
 5-23 secretary of state shall promulgate any materials and provide any
 5-24 training to presiding judges necessary to properly process voters
 5-25 under this subsection [~~In an election ordered by a city, early~~
 5-26 ~~voting by personal appearance at the main early voting polling~~
 5-27 ~~place shall be conducted for at least 12 hours.~~

5-28 [~~(1) on one weekday, if the early voting period~~
 5-29 ~~consists of less than six weekdays, or~~

5-30 [~~(2) on two weekdays, if the early voting period~~
 5-31 ~~consists of six or more weekdays].~~

5-32 SECTION 2.08. Sections 85.006(b) and (e), Election Code,
 5-33 are amended to read as follows:

5-34 (b) In an election in which a county clerk [~~or city~~
 5-35 ~~secretary~~] is the early voting clerk under Section 83.002 [~~or~~
 5-36 ~~83.005~~], only the early voting clerk may order voting on a Saturday
 5-37 or Sunday. The clerk must do so by written order.

5-38 (e) In a primary election or the general election for state
 5-39 and county officers in a county with a population of 30,000
 5-40 [~~100,000~~] or more, the early voting clerk shall order voting by
 5-41 personal appearance [~~voting~~] at the main early voting polling place
 5-42 to be conducted on the last Saturday of the early voting period for
 5-43 at least 12 hours, except that voting may not be conducted earlier
 5-44 than 6 a.m. or later than 9 p.m., [on the last Saturday] and on the
 5-45 last Sunday of the early voting period for at least six [five]
 5-46 hours, except that voting may not be conducted earlier than 6 a.m.
 5-47 or later than 9 p.m. [on the last Sunday of the early voting period].
 5-48 The early voting clerk shall order voting to be conducted at those
 5-49 times in those elections in a county with a population under 30,000
 5-50 [~~100,000~~] on receipt of a written request for those hours submitted
 5-51 by at least 15 registered voters of the county. The request must be
 5-52 submitted in time to enable compliance with Section 85.007. This
 5-53 subsection supersedes any provision of this subchapter to the
 5-54 extent of any conflict.

5-55 SECTION 2.09. Section 85.010(a-1), Election Code, is
 5-56 amended to read as follows:

5-57 (a-1) In this section, "eligible county polling place"
 5-58 means an early voting polling place [~~, other than a polling place~~
 5-59 ~~established under Section 85.062(c),~~] established by a county.

5-60 SECTION 2.10. Section 85.061, Election Code, is amended by
 5-61 amending Subsection (a) and adding Subsections (a-1) and (a-2) to
 5-62 read as follows:

5-63 (a) In a countywide election in which the county clerk is
 5-64 the early voting clerk under Section 83.002, an early voting
 5-65 polling place shall be located inside [~~at~~] each branch office that
 5-66 is regularly maintained for conducting general clerical functions
 5-67 of the county clerk, except as provided by Subsection (b). If a
 5-68 suitable room is unavailable inside the branch office, the polling
 5-69 place may be located in another room inside the same building as the

6-1 branch office. Except as provided by Subsection (a-1), the polling
 6-2 place may not be located in a tent or similar temporary moveable
 6-3 structure or a parking garage, parking lot, or similar facility
 6-4 designed primarily for motor vehicles.

6-5 (a-1) An early voting polling place may be located in a tent
 6-6 or similar temporary moveable structure if:

6-7 (1) a building selected for an early voting polling
 6-8 place is later determined by the county commissioners court to be
 6-9 not reasonably accessible due to fire, flood, or other natural
 6-10 disaster rendering the building unsafe for public use;

6-11 (2) a suitable substitute building is not available;
 6-12 and

6-13 (3) the tent or similar temporary moveable structure
 6-14 is adjacent to the building described by Subdivision (1).

6-15 (a-2) If the county commissioners court makes a
 6-16 determination described by Subsection (a-1)(1):

6-17 (1) the determination is valid only for the next
 6-18 scheduled election; and

6-19 (2) the court shall send a record of that
 6-20 determination to the secretary of state as soon as practicable.

6-21 SECTION 2.11. Section 85.062, Election Code, is amended by
 6-22 amending Subsection (b) and adding Subsections (b-1), (b-2), and
 6-23 (f-1) to read as follows:

6-24 (b) A polling place established under this section may be
 6-25 located, subject to Subsection (d), at any place in the territory
 6-26 served by the early voting clerk and may be located inside [~~in~~]
 6-27 building [~~stationary structure~~] as directed by the authority
 6-28 establishing the branch office. Except as provided by Subsection
 6-29 (b-1), the [~~The~~] polling place may not be located in a tent or
 6-30 similar temporary movable structure or a parking garage, parking
 6-31 lot, or similar facility designed primarily for motor vehicles in
 6-32 the general election for state and county officers, general primary
 6-33 election, or runoff primary election. Ropes or other suitable
 6-34 objects may be used at the polling place to ensure compliance with
 6-35 Section 62.004. Persons who are not expressly permitted by law to
 6-36 be in a polling place shall be excluded from the polling place to
 6-37 the extent practicable.

6-38 (b-1) A temporary branch polling place may be located in a
 6-39 tent or similar temporary moveable structure if:

6-40 (1) a building selected for a temporary branch polling
 6-41 place is later determined by the county commissioners court to be
 6-42 not reasonably accessible due to fire, flood, or other natural
 6-43 disaster rendering the building unsafe for public use;

6-44 (2) a suitable substitute building is not available;
 6-45 and

6-46 (3) the tent or similar temporary moveable structure
 6-47 is adjacent to the building described by Subdivision (1).

6-48 (b-2) If the county commissioners court makes a
 6-49 determination described by Subsection (b-1)(1):

6-50 (1) the determination is valid only for the next
 6-51 scheduled election; and

6-52 (2) the court shall send a record of that
 6-53 determination to the secretary of state as soon as practicable.

6-54 (f-1) Notwithstanding any other provision of this section
 6-55 concerning the location of temporary branch polling places, in an
 6-56 election in which countywide polling places are used, the
 6-57 commissioners court of a county shall employ the same methodology
 6-58 it uses to determine the location of countywide polling places to
 6-59 determine the location of temporary branch polling places.

6-60 SECTION 2.12. Section 124.002, Election Code, is amended by
 6-61 adding Subsection (c) to read as follows:

6-62 (c) Voting system ballots may not be arranged in a manner
 6-63 that allows a political party's candidates to be selected in one
 6-64 motion or gesture.

6-65 SECTION 2.13. Section 127.1232, Election Code, is amended
 6-66 to read as follows:

6-67 Sec. 127.1232. SECURITY OF VOTED BALLOTS. (a) The general
 6-68 custodian of election records shall post a licensed peace officer
 6-69 [~~guard~~] to ensure the security of ballot boxes containing voted

7-1 ballots throughout the period of tabulation at the central counting
7-2 station.

7-3 (b) The general custodian of election records in a county
7-4 with a population of less than 100,000 may, and the general
7-5 custodian of election records in a county with a population of
7-6 100,000 or more shall, implement a video surveillance system that
7-7 retains a record of all areas containing voted ballots:

7-8 (1) from the time the voted ballots are delivered to
7-9 the central counting station until the canvass of precinct election
7-10 returns; and

7-11 (2) from the time the voted ballots are delivered to
7-12 the signature verification committee or early voting ballot board
7-13 until the canvass of precinct election returns.

7-14 (c) A video from a system implemented under Subsection (b)
7-15 may be made available to the public by a livestream in a county with
7-16 a population of less than 100,000, and shall be made available to
7-17 the public by a livestream in a county with a population of 100,000
7-18 or more.

7-19 (d) The video recorded is an election record under Section
7-20 1.012 and shall be retained by the general custodian of election
7-21 records until the end of the calendar year in which an election is
7-22 held or until an election contest filed in the county has been
7-23 resolved, whichever is later.

7-24 ARTICLE 3. ELECTION OFFICERS AND OBSERVERS

7-25 SECTION 3.01. Subchapter A, Chapter 33, Election Code, is
7-26 amended by adding Section 33.008 to read as follows:

7-27 Sec. 33.008. TRAINING MANUAL. (a) The secretary of state
7-28 shall publish and maintain a training manual for watchers and shall
7-29 make the manual available on the secretary of state's Internet
7-30 website.

7-31 (b) An appointing authority must provide each watcher
7-32 appointed by the authority with a copy of the training manual
7-33 maintained under this section.

7-34 SECTION 3.02. Section 33.051, Election Code, is amended by
7-35 adding Subsections (g) and (h) to read as follows:

7-36 (g) An election officer commits an offense if the officer
7-37 intentionally or knowingly refuses to accept a watcher for service
7-38 when acceptance of the watcher is required by this section. An
7-39 offense under this subsection is a Class A misdemeanor.

7-40 (h) Before accepting a watcher, the officer presented with a
7-41 watcher's certificate of appointment shall require the watcher to
7-42 take the following oath, administered by the officer: "I swear (or
7-43 affirm) that I will not disrupt the voting process or harass voters
7-44 in the discharge of my duties."

7-45 SECTION 3.03. Section 33.056, Election Code, is amended by

7-52 conducting the observed activity, except as otherwise prohibited by
7-53 this chapter.

7-54 (e) Except as provided by Section 33.057(b), a watcher may
7-55 not be denied free movement where election activity is occurring
7-56 within the location at which the watcher is serving.

7-57 (f) In this code, a watcher who is entitled to "observe" an
7-58 election activity is entitled to sit or stand near enough to see and
7-59 hear the activity.

7-60 SECTION 3.04. Subchapter C, Chapter 33, Election Code, is
7-61 amended by adding Section 33.0605 to read as follows:

7-62 Sec. 33.0605. OBSERVING DATA STORAGE SEALING AND TRANSFER.

7-63 (a) A watcher appointed to serve at a polling place in an election
7-64 who is available at the time of the action may observe all election
7-65 activities relating to closing the polling place, including the
7-66 sealing and transfer of a memory card, flash drive, hard drive, data
7-67 storage device, or other medium now existing or later developed
7-68 used by the voting system equipment.

7-69 (b) Notwithstanding any other provision of this code, a

8-1 watcher duly accepted for service at a polling location is entitled
 8-2 to follow the transfer of election materials from the polling place

 11-13 requirement prescribed by Section 86.003(c).

ARTICLE 5. ASSISTANCE OF VOTERS

SECTION 5.01. Section 64.009, Election Code, is amended by amending Subsection (b) and adding Subsections (e), (f), (f-1), (g), and (h) to read as follows:

(b) The regular voting procedures, except those in Subchapter B, may be modified by the election officer to the extent necessary to conduct voting under this section.

(f-1) Subsection (f) does not apply if the person is related to each voter within the second degree by affinity or the third degree by consanguinity, as determined under Subchapter B, Chapter 573, Government Code.

(g) A form completed under Subsection (f) shall be delivered to the secretary of state as soon as practicable. The secretary shall retain a form delivered under this section for the period for preserving the precinct election records and shall make the form available to the attorney general for inspection upon request.

(h) The secretary of state shall prescribe the form described by Subsection (f).

SECTION 5.02. Section 64.031, Election Code, is amended to read as follows:

Sec. 64.031. ELIGIBILITY FOR ASSISTANCE. A voter is eligible to receive assistance in marking or reading the ballot, as provided by this subchapter, if the voter cannot prepare or read the ballot because of:

(1) a physical disability that renders the voter unable to write or see; or

(2) an inability to read the language in which the ballot is written.

SECTION 5.03. Subchapter B, Chapter 64, Election Code, is amended by adding Section 64.0322 to read as follows:

Sec. 64.0322. SUBMISSION OF FORM BY ASSISTANT. (a) A person, other than an election officer, who assists a voter in accordance with this chapter is required to complete a form stating:

SECTION 5.04. Section 64.034, Election Code, is amended to read as follows:

Sec. 64.034. OATH. A person, other than an election officer, selected to provide assistance to a voter must take the following oath, administered by an election officer at the polling place, before providing assistance:

"I swear (or affirm) under penalty of perjury that the voter I am assisting represented to me they are eligible to receive assistance; I will not suggest, by word, sign, or gesture, how the voter should vote; [I will confine my assistance to answering the voter's questions, to stating propositions on the ballot, and to naming candidates and, if listed, their political parties,] I will prepare the voter's ballot as the voter directs; I did not

 17-27 vote harvesting services.

17-28 (d) A person commits an offense if the person knowingly
 17-29 collects or possesses a mail ballot or official carrier envelope in
 17-30 connection with vote harvesting services.

17-31 (e) This section does not apply to:

17-32 (1) an activity not performed in exchange for
 17-33 compensation or a benefit;

17-34 (2) interactions that do not directly involve an
 17-35 official ballot, ballot by mail, or an application for ballot by
 17-36 mail;

17-37 (3) interactions that are not conducted in-person with
 17-38 a voter; or

17-39 (4) activity that is not designed to deliver votes for
 17-40 or against a specific candidate or measure.

17-41 (f) In this section, compensation in exchange for vote
 17-42 harvesting services is inferred if a person who performed vote
 17-43 harvesting services for a candidate or campaign solicits, receives,
 17-44 or is offered compensation from the candidate or campaign, directly
 17-45 or through a third party, for services other than vote harvesting
 17-46 services provided.

17-47 (g) An offense under this section is a felony of the third
 17-48 degree.

17-49 (h) If conduct that constitutes an offense under this
 17-50 section also constitutes an offense under any other law, the actor

17-52 (i) Records necessary to investigate an offense under this
 17-53 section or any other section of this code shall be provided by an

 18-17 votes by which the party lost the election shall recover damages in
 18-18 an amount including any or all of:

18-19 (1) the party's campaign expenditures properly filed
 18-20 on a campaign finance report in connection with the election; or

18-21 (2) any fees and expenses incurred by the party in
 18-22 filing and securing a place on the ballot.

18-23 (e) A person who commits an offense under Section 276.015
 18-24 and is found civilly liable, including by vicarious liability,
 18-25 under this chapter or other law for any amount of damages arising
 18-26 from the vote harvesting services is jointly liable with any other
 18-27 defendant for the entire amount of damages arising from the vote
 18-28 harvesting services.

18-29 (f) The cause of action created by this section is
 18-30 cumulative of any other remedy provided by common law or statute.

18-31 (g) Rules applicable to a party's access to election records
 18-32 under Chapter 231 or 232 apply to a cause of action under this
 18-33 section.

18-34 (h) The expedited actions process created by Rule 169, Texas
 18-35 Rules of Civil Procedure, does not apply to an action under this
 18-36 section.

18-37 (i) Chapter 27, Civil Practice and Remedies Code, does not
 18-38 apply to a cause of action under this section.

18-39 (j) A cause of action under this section may be brought in
 18-40 the county where any element of a violation under Section 276.015
 18-41 occurred, or where any part of the vote harvesting services
 18-42 occurred.

18-43 (k) This section shall be liberally construed and applied to
 18-44 promote its underlying purpose to protect candidates and the voting
 18-45 public from unlawful vote harvesting and provide an efficient and
 18-46 economical remedy to secure that protection.

18-47 Sec. 276.017. UNLAWFUL ALTERING OF ELECTION PROCEDURES. A
 18-48 public official may not create, alter, modify, waive, or suspend
 18-49 any election standard, practice, or procedure mandated by law or
 18-50 rule in a manner not expressly authorized by this code.

ARTICLE 7. ENFORCEMENT

 21-31 the Federal Employers' Liability Act and the Jones Act;
 21-32 (6) appeals of final orders of the commissioner of the
 21-33 General Land Office under Section 51.3021, Natural Resources Code;
 21-34 (7) actions in which the claimant has been diagnosed
 21-35 with malignant mesothelioma, other malignant asbestos-related
 21-36 cancer, malignant silica-related cancer, or acute silicosis; and
 21-37 (8) appeals brought under Section 42.01 or 42.015, Tax
 21-38 Code, of orders of appraisal review boards of appraisal districts
 21-39 established for counties with a population of less than 175,000.
 21-40 (b-1) Except for a criminal case in which the death penalty
 21-41 has been or may be assessed or when it would otherwise interfere
 21-42 with a constitutional right, the trial courts of this state shall
 21-43 prioritize over any other proceeding pending or filed in the court a
 21-44 proceeding for injunctive relief under Chapter 273, Election Code,
 21-45 pending or filed in the court on or after the 120th day before a
 21-46 general or special election.
 21-47 **ARTICLE 8. INELIGIBLE VOTERS AND RELATED REFORMS**
 21-48 **SECTION 8.01.** Chapter 42, Code of Criminal Procedure, is
 21-49 amended by adding Article 42.0194 to read as follows:
 21-50 Art. 42.0194. FINDING REGARDING FELONY CONVICTION. In the
 21-51 trial of a felony offense, if the defendant is 18 years of age or
 21-52 older and is adjudged guilty of the offense, the court shall:
 21-53 (1) make an affirmative finding that the person has
 21-54 been found guilty of a felony and enter the affirmative finding in
 21-55 the judgment of the case; and
 21-56 (2) instruct the defendant regarding how the felony
 21-57 conviction will impact the defendant's right to vote in this state.
 21-58 **SECTION 8.02.** Article 42.01, Code of Criminal Procedure, as
 21-59 effective September 1, 2021, is amended by adding Section 16 to read
 21-60 as follows:
 21-61 Sec. 16. In addition to the information described by
 21-62 Section 1, the judgment should reflect the affirmative finding and
 21-63 instruction entered pursuant to Article 42.0194.
 21-64 **ARTICLE 9. REPEALER; SEVERABILITY; TRANSITION; EFFECTIVE DATE**
 21-65 **SECTION 9.01.** The following provisions of the Election Code
 21-66 are repealed:
 21-67 (1) Section 85.062(e); and
 21-68 (2) Section 127.201(f).
 21-69 **SECTION 9.02.** If any provision of this Act or its

22-1 application to any person or circumstance is held invalid, the
22-2 invalidity does not affect other provisions or applications of this
22-3 Act that can be given effect without the invalid provision or
22-4 application, and to this end the provisions of this Act are declared
22-5 to be severable.

22-6 SECTION 9.03. (a) Except as otherwise provided by this Act,
22-7 the changes in law made by this Act apply only to an offense
22-8 committed on or after the effective date of this Act. An offense
22-9 committed before the effective date of this Act is governed by the
22-10 law in effect when the offense was committed, and the former law is
22-11 continued in effect for that purpose. For purposes of this section,
22-12 an offense was committed before the effective date of this Act if
22-13 any element of the offense occurred before that date.

22-14 (b) The changes in law made by this Act apply only to an
22-15 election ordered on or after the effective date of this Act. An
22-16 election ordered before the effective date of this Act is governed
22-17 by the law in effect when the election was ordered, and the former
22-18 law is continued in effect for that purpose.

22-19 (c) The changes in law made by this Act apply only to an
22-20 election contest for which the associated election occurred after
22-21 the effective date of this Act.

22-22 (d) The changes in law made by this Act apply only to an
22-23 application to vote an early voting ballot by mail submitted on or
22-24 after the effective date of this Act. An application to vote an
22-25 early voting ballot by mail submitted before the effective date of
22-26 this Act is governed by the law in effect when the application was
22-27 submitted, and the former law is continued in effect for that
22-28 purpose.

22-29 (e) The changes in law made by this Act apply only to an
22-30 application for voter registration submitted on or after the
22-31 effective date of this Act.

22-32 SECTION 9.04. This Act takes effect on the 91st day after
22-33 the last day of the legislative session.
