5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. This Act may be cited as the Christine Blubaugh
7	Act.
8	SECTION 2. Section 28.002, Education Code, is amended by
9	adding Subsections (u), (u-1), (u-2), and (u-3) to read as follows:
10	(u) The State Board of Education shall adopt rules requiring
11	students to receive instruction on the prevention of child abuse,
12	family violence, and dating violence at least once in middle or
13	junior high school and at least once in high school. The
14	instruction must include information on:
15	(1) the dating violence policy adopted by the
16	student's school district under Section 37.0831;
17	(2) the prevalence of dating violence and the
18	recognition of abuse warning signs;
19	(3) the procedures for reporting violence or abuse;

21	(4) educational materials or resources available to
22	students under Section 37.0831(c).
23	(u-1) Before each school year, a school district shall
24	provide written notice as described by Subsection (u-2) to a parent

1 of each student enrolled in the district who will receive: 2 (1) the instruction required by Subsection (u); or (2) any other instruction required by state law 3 relating to the prevention of child abuse, family violence, and 4 5 dating violence. 6 (u-2) The written notice required by Subsection (u-1) must 7 include: 8 (1) a statement that the district will provide instruction to the parent's student relating to the prevention of 9 child abuse, family violence, and dating violence; 10 11 (2) a description of: 12 (A) the curriculum materials that will be used in providing instruction to the parent's student relating to the 13 prevention of child abuse, family violence, and dating violence; 14 15 and (B) the educational materials and resources 16 17 described by Section 37.0831(c); and 18 (3) a statement of the parent's right to: 19 (A) review the materials and resources described 20 by Subdivision (2); and 21 (B) remove the student from instruction relating to the prevention of child abuse, family violence, and dating 22 23 violence without subjecting the student to any disciplinary action, 24 academic penalty, or other sanction imposed by the district or the student's school. 25 26 (u-3) If a school district does not comply with the requirements of Subsections (u-1) and (u-2), a parent of a student 27

The heading to Section 37.0831, Education Code, 5 is amended to read as follows: Sec. 37.0831. DATING POLICIES; EDUCATIONAL 6 VIOLENCE 7 MATERIALS AND RESOURCES. Section 37.0831, Education Code, as amended by 8 SECTION 4. S.B. No. 1267, Acts of the 87th Legislature, Regular Session, 2021, 9 10 is amended by amending Subsection (b) and adding Subsection (c) to read as follows: 11 12 (b) A dating violence policy must: 13 (1) include: 14 (A) a definition of dating violence that includes

4 (c) To the extent possible, a school district shall make
5 available to students:

6 <u>(1) age-appropriate educational materials that</u> 7 <u>include information on the dangers of dating violence; and</u>

(2) resources to students seeking help.

9 SECTION 5. This Act applies beginning with the 2022-2023 10 school year.

11 SECTION 6. This Act takes effect immediately if it receives 12 a vote of two-thirds of all the members elected to each house, as 13 provided by Section 39, Article III, Texas Constitution. If this 14 Act does not receive the vote necessary for immediate effect, this 15 Act takes effect on the 91st day after the last day of the 16 legislative session.
