The county chair shall 8 9 conduct the drawing to determine the order of the candidates' names on the general primary election ballot in accordance with Section 10
- (e) If a redistricting plan to which this section applies 12 13 has not become law on or before February 7, 2022, the secretary of state shall set the dates of the filing period and the general and 14 runoff primary elections for the election of officers of the 15 16 districts to which this section applies. In setting dates under this subsection, the secretary of state shall ensure the efficient 17 18 and orderly administration of elections and shall, to the extent practicable, set dates in a manner that allows the same interval of 19 20 time in relation to the date of the election as would be provided by the application of other law. 21

- SECTION 2. This Act takes effect immediately if it receives
- 19 a vote of two-thirds of all the members elected to each house, as
- 20 provided by Section 39, Article III, Texas Constitution. If this
- 21 Act does not receive the vote necessary for immediate effect, this
- 22 Act takes effect on the 91st day after the last day of the
- 23 legislative session.
