5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Chapter 161, Health and Safety Code, is amended
7	by adding Subchapter X to read as follows:
8	SUBCHAPTER X. GENDER TRANSITIONING AND GENDER REASSIGNMENT
9	PROCEDURES AND TREATMENTS FOR CERTAIN CHILDREN
10	Sec. 161.701. DEFINITIONS. In this subchapter:
11	(1) "Child" means an individual who is younger than 18
12	years of age.
13	(2) "Health care provider" means a person other than a
14	physician who is licensed, certified, or otherwise authorized by
15	the laws of this state to provide or render health care or to
16	dispense or prescribe a prescription drug in the ordinary course of
17	business or practice of a profession.
18	(3) "Physician" means a person licensed to practice
19	medicine in this state.
20	Sec. 161.702. PROHIBITED PROVISION OF GENDER TRANSITIONING
21	OR GENDER REASSIGNMENT PROCEDURES AND TREATMENTS TO CERTAIN
22	CHILDREN. For the purpose of transitioning a child's biological

         Sec. 161.703. EXCEPTIONS. The prohibitions under Section

- 2 of appropriate and medically necessary gender transitioning or
- 3 gender reassignment procedures or treatments to a child who:
- 4 (1) is born with a medically verifiable genetic

- 7 (B) 46, XY chromosomes with undervirilization;

- 9 (C) both ovarian and testicular tissue; or
- 10 (2) does not have the normal sex chromosome structure

- 13 Sec. 161.704. PROHIBITED USE OF PUBLIC MONEY FOR GENDER
- 14 TRANSITIONING OR GENDER REASSIGNMENT PROCEDURES AND TREATMENTS FOR
- 15 CERTAIN CHILDREN. A state agency, entity, or other person may not
- 16 use public money, including money appropriated by the legislature,
- 17 to directly or indirectly provide to a child gender transitioning
- 18 or gender reassignment procedures or treatments for the purpose of
- 19 transitioning the child's biological sex as determined by the sex
- 20 organs, chromosomes, and endogenous profiles of the child or
- 21 affirming the child's perception of the child's sex if that
- 22 perception is inconsistent with the child's biological sex.
- Sec. 161.705. DISCIPLINARY ACTION. The Texas Medical Board
- 24 or another state regulatory agency with jurisdiction over a health
- 25 care provider subject to Section 161.702 shall revoke the license,
- 26 <u>certification</u>, or authorization of a physician or health care
- 27 provider who the board or agency determines has violated that

- 2 SECTION 2. Subchapter F, Chapter 1901, Insurance Code, is
- 3 amended by adding Section 1901.256 to read as follows:
- 4 Sec. 1901.256. PROHIBITED COVERAGE FOR PROVISION OF CERTAIN
- 5 GENDER-RELATED PROCEDURES AND TREATMENTS TO CERTAIN CHILDREN. A
- 6 professional liability insurance policy issued to a physician or
- 7 health care provider may not include coverage for damages assessed
- 8 against the physician or health care provider who provides to a
- 9 child gender transitioning or gender reassignment procedures or
- 10 treatments that are prohibited by Section 161.702, Health and
- 11 Safety Code.
- 12 SECTION 3. Section 1901.256, Insurance Code, as added by
- 13 this Act, applies only to a medical professional liability
- 14 insurance policy that is delivered, issued for delivery, or renewed
- 15 on or after March 1, 2022. An insurance policy that is delivered,
- 16 issued for delivery, or renewed before March 1, 2022, is governed by
- 17 the law in effect immediately before the effective date of this Act,
- 18 and that law is continued in effect for that purpose.
- 19 SECTION 4. This Act takes effect immediately if it receives
- 20 a vote of two-thirds of all the members elected to each house, as
- 21 provided by Section 39, Article III, Texas Constitution. If this
- 22 Act does not receive the vote necessary for immediate effect, this
- 23 Act takes effect on the 91st day after the last day of the
- 24 legislative session.
